AMENDED APPLICATION

COMES NOW Bill Barrett Corporation ("Applicant"), a Delaware corporation, by its attorneys, Beatty & Wozniak, P.C., and makes **this amended** application to the Oil and Gas Conservation Commission of the State of Colorado for an order establishing spacing and well location rules applicable to the drilling and producing of horizontal wells from the Gothic Shale Formation underlying certain lands in Dolores and Montezuma Counties, Colorado and in support of its **amended** application states and alleges as follows:

3. That the Application Lands are unspaced as to the Gothic Shale Formation and subject to the Commission's Rule 318.

4. That Applicant has undertaken an exploration program by the drilling of horizontal wells into the Gothic Shale Formation in the area of the Application Lands and has determined that potentially commercial reserves of gas are recoverable from this formation underlying the Application Lands.

5. That to promote efficient drainage within this formation underlying the Application Lands, the Commission should establish the following described approximate 1,280 acre drilling and spacing units consisting of the Application Lands and permit the drilling on each of these drilling and spacing units up to a maximum of eight (8) horizontal wells:

6. That as each horizontal well drilled within a given approximate 1,280 acre drilling and spacing unit, the surface location for the well may be located anywhere upon the drilling unit (or adjoining lands to such unit) provided that the horizontal leg into the Gothic Shale Formation shall not be any closer than 460 feet to the outside boundary of the drilling unit and the terminus of the horizontal leg shall not be any closer than 460 feet to the outside boundary of the drilling unit without exception being granted by the Director of the Oil and Gas Conservation Commission.

7. That as to the horizontal wells to be drilled into and produced from a given approximate 1,280 acre drilling and spacing unit, such wells will be drilled from no more than 8 pads located on the surface of such unit or adjoining lands to the unit. It is provided, however, that Applicant, in circumstances where topographic and surface owner approval conditions permit, will undertake reasonable efforts to utilize even fewer pads by locating its pads near the center of a given drilling and spacing unit.

8. The granting of this **amended** application will not promote waste; will not violate correlative rights and will assure the greatest ultimate recovery of gas and associated hydrocarbon substances from the reservoir.

9. That the names and addresses of the interested parties according to the information and belief of the Applicant are set forth in Exhibit B attached hereto and made a part hereof.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing in January, 2009, that notice be given as required by law and that upon such hearing this Commission enter its order consistent with Applicant's proposals as set forth above.

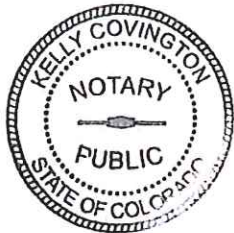

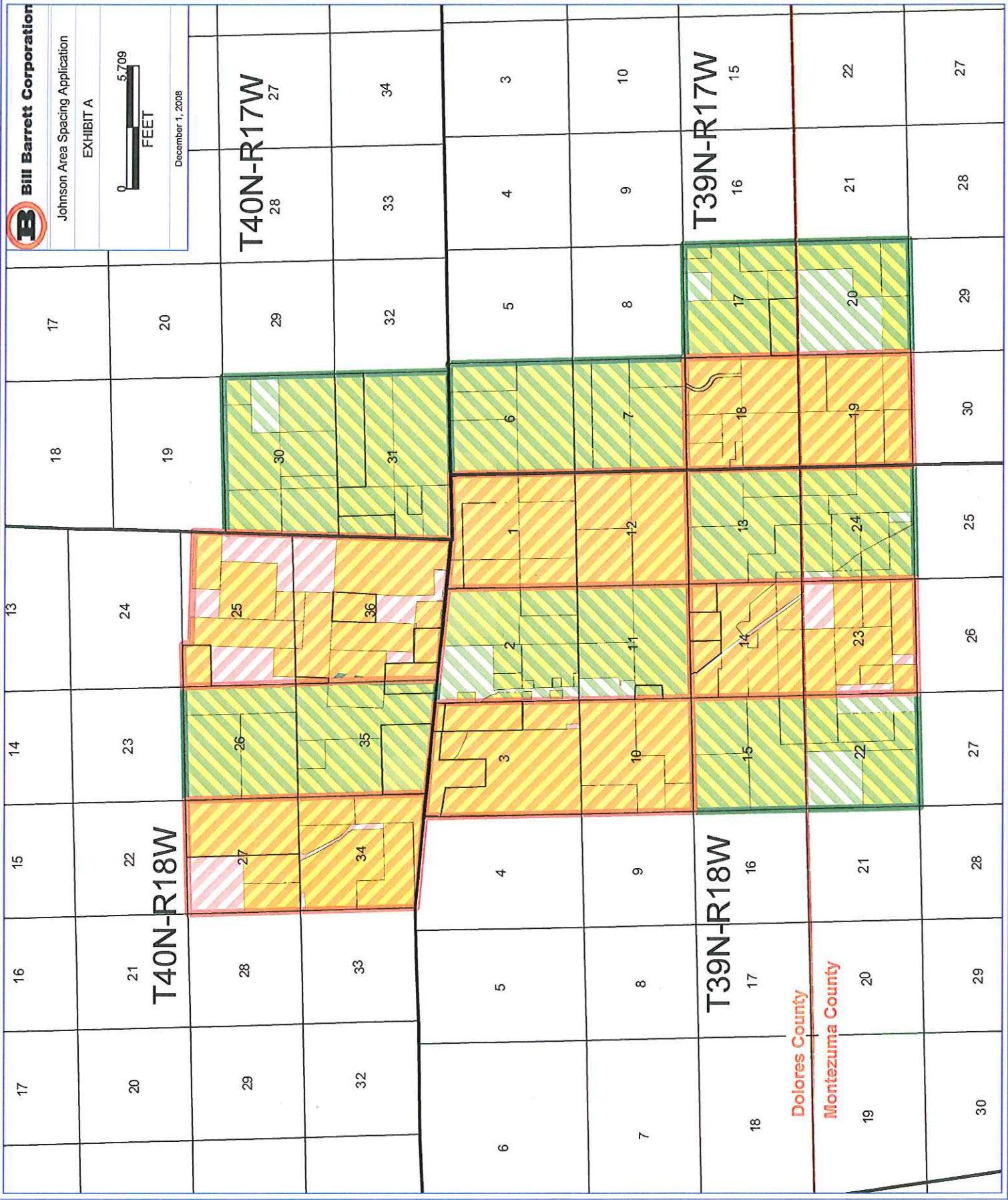
