Additional information for this well:

#### (1) Wellbore Spacing Unit

The wellbore spacing unit will be comprised of the 1N-66W Section 9: E/2SW/4, W/2SE/4 as depicted on the enclosed plat. The working interests attributable to the Codell/Niobrara and J-Sand formations in the contributing 40 acre quarter-quarter sections will be utilized to determine the interests of the parties in the proposed 160 acre spacing unit for this well. 
