APPLICATION

Noble Energy Inc. ("Noble"), by and through its attorneys, Beatty & Wozniak, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order allowing an exception location for a well to be completed in the Codell and Niobrara Formations in the NW/4NW/4, Section 30, Township 3 North, Range 66 West, Weld County, Colorado ("Application Lands"). In support thereof, Noble Energy, Inc. (referred to herein as "Applicant") states and alleges as follows:

1. Pursuant to an exception location filed in December, 1999 (a copy of which is attached), Applicant drilled the Lorenz L30-4D on February 4, 2000 to the Dakota and JSand Formations at the following approximate legal bottomhole location: 334' FNL and 818' FWL in the Application Lands. Applicant intends to recomplate the Lorenz L30-4D into the Codell Niobrara formation.

2. The Application Lands are subject to Rule 318.a., Rule 318A and Rule 318A(e) of the Rules and Regulations of this Commission. Rule 318.a.establishes a well drilled in excess of two thousand five hundred feet (2,500) in depth shall be located not less than six hundred (600) feet from any lease line, and shall be located not less than one thousand two hundred (1,200) feet from any producible or drilling oil and gas well when drilling to the same source of supply, unless authorized by order of the Commission upon hearing.

3. Consistent with Rule 318A.b. Applicant seeks an exception from Rule 318a in that it seeks to recomplate the Lorenz L30-4D at its current location approximately 359 feet from the North line and 862 feet from the West line.

4. That in order to prevent waste and protect correlative rights of all owners in the area surrounding the proposed location, it is reasonable and equitable to permit an exception location to allow the recompletion of a well in the described location. Applicant also asserts that Rule 318.c. of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission provides for exception locations when geologic, topographical or environmental conditions warrant a variance from field rules.

5. Contiguous and cornering owners of lands toward whom the well is located and are affected by the exception location and have not executed waivers consenting to this exception location are set forth on Exhibit A attached hereto. Applicant is the operator of the offset unit to the proposed exception location and royalty owners comprise the majority of those parties identified on Exhibit A. There are working interest owners as well. Additionally, the undersigned certifies that copies of this Application shall be served on each interested party within the next seven days as required by Rule 503.d.

WHEREFORE, Applicant respectfully requests that either the Director approve this request pursuant to Rule 502b.(1) or, if necessary, this matter be set for hearing at the next regular hearing date, that notice thereof be given as required by law and that upon such hearing the Commission enter its order:

A. Determining that the Lorenz L30-4D Well may be recompleted and produce from Codell and Niobrara Formations at its present location in the Application Lands.

B. Granting any other relief necessary to prevent waste and protect correlative rights of the owners.
