APPLICATION

Bill Barrett Corporation ("BBC" or "Applicant"), by and through its attorneys, Burleson LLP, respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order: (1) maintaining the approximate 80-acre drilling and spacing units previously established for Section 9, Township 6 North, Range 66 North, 6th P.M., for any existing well capable of producing oil, gas and associated hydrocarbons from the Niobrara Formation; and (2) establishing an approximate 640-acre drilling and spacing unit for said Section 9, and authorizing the drilling of up to twenty (20) horizontal wells within the proposed unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. In support of its Application, Applicant states and alleges as follows:

- 1. Applicant is a corporation duly authorized to conduct business in the State of Colorado, and has registered as an operator with the Commission.
 - 2. Applicant owns the entire leasehold interests in the below-listed lands:

Township 6 North, Range 66 West, 6th P.M. Section 9: All

These lands are hereinafter referred to as the "Application Lands." A map depicting the acreage comprising the Application Lands is attached hereto and marked as Exhibit A.

Maintaining the 80-acre drilling and spacing units established by Order No. 407-87

- 3. On or about February 19, 1992, the Commission entered Order No. 407-87 (which was amended on August 23, 1993) which, among other things, established 80-acre drilling and spacing units for certain lands, including the Application Lands, with permitted well locations in accordance with the provisions of Order No. 407-1, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations.
- 4. On April 27, 1998, the Commission adopted Rule 318A. which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all Cretaceous Age Formations from the base of the Dakota Formation to the surface. Rule 318A. supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of Greater Wattenberg Area wells. On December 5, 2005, Rule 318A was amended, among other things, to allow interior

infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address drilling of horizontal wells. The Application Lands are subject to this rule for the Niobrara Formation.

- 5. BBC operates the A & N Farms #12-9 Well, API #05-123-22621, a well producing hydrocarbons from the Niobrara Formation and spaced under Order No. 407-87, said well located in the SW¼ NW¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the A & N Farms #12-9 Well; Order No. 407-87 is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 6. BBC operates the CEI-Gutterson #1 Well, API #05-123-12383, a well producing hydrocarbons from the Niobrara Formation, said well located in the NW¼ SW¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the CEI-Gutterson #1 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 7. BBC operates the Lovely #14-9 Well, API #05-123-22620, a well producing hydrocarbons from the Niobrara Formation and spaced under Order No. 407-87, said well located in the SW¼ SW¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Lovely #14-9 Well; Order No. 407-87 is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 8. BBC operates the A & N Farms #21-9 Well, API #05-123-13983, a well producing hydrocarbons from the Niobrara Formation, said well located in the NE¼ NW¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the A & N Farms #21-9 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 9. BBC operates the A & N Farms #22-9 Well, API #05-123-13999, a well producing hydrocarbons from the Niobrara Formation, said well located in the SE¼ NW¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the A & N Farms #22-9 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 10. BBC operates the Gutterson #23-9 Well, API #05-123-23118, a well producing hydrocarbons from the Niobrara Formation and spaced under Order No. 407-87, said well located in the NE¼ SW¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Gutterson #23-9 Well; Order No. 407-87 is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 11. BBC operates the Lovely #1 Well, API #05-123-12684, a well producing hydrocarbons from the Niobrara Formation, said well located in the SE¼ SW¼ of Section 9,

Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Lovely #1 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.

- 12. BBC operates the Indian Tree #31-9 Well, API #05-123-14020, a well producing hydrocarbons from the Niobrara Formation, said well located in the NW½ NE½ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Indian Tree #31-9 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 13. BBC operates the Indian Tree #32-9 Well, API #05-123-23262, a well producing hydrocarbons from the Niobrara Formation and spaced under Order No. 407-87, said well located in the SW¼ NE¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Lovely #32-9 Well; Order No. 407-87 is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 14. BBC operates the Lucas School #34-9 Well, API #05-123-14000, a well producing hydrocarbons from the Niobrara Formation, said well located in the SW¼ SE¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Lucas School #34-9 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 15. BBC operates the Indian Tree #1 Well, API #05-123-12706, a well producing hydrocarbons from the Niobrara Formation, said well located in the NE¼ NE¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Indian Tree #1 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 16. BBC operates the Indian Tree #42-9 Well, API #05-123-23263, a well producing hydrocarbons from the Niobrara Formation and spaced under Order No. 407-87, said well located in the SE¼ NE¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Indian Tree #42-9 Well; Order No. 407-87 is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.
- 17. BBC operates the Lucas School #43-9 Well, API #05-123-25602, a well producing hydrocarbons from the Niobrara Formation and spaced under Order No. 407-87, said well located in the NE¼ SE¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Lucas School #43-9 Well; Order No. 407-87 is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.

18. BBC operates the Lucas School #1 Well, API #05-123-12599, a well producing hydrocarbons from the Niobrara Formation, said well located in the SE¼ SE¼ of Section 9, Township 6 North, Range 66 West, 6th P.M. Under this Application, BBC is not requesting a change to the unit acreage assigned to the Lucas School #1 Well; the 80 acres assigned to the well is to be maintained and the distribution of proceeds from the well will continue to be allocated on an 80-acre basis.

Establishment of the 640-acre Drilling Unit for Horizontal Well Development

- 19. Applicant requests the Commission establish the Application Lands as an approximate 640-acre drilling and spacing unit for the Niobrara Formation pursuant to Rule 503.b.(1) and §34-60-116(2), C.R.S. For the Application Lands, the proposed drilling unit is not smaller than the maximum area that can be economically and efficiently drained by the horizontal wells proposed to be drilled under this Application and completed in the Niobrara Formation.
- 20. Applicant requests it be authorized to drill and complete up to twenty (20) horizontal wells in the approximate 640-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, as necessary to economically and efficiently recover resources, while minimizing surface impacts, creating efficiencies for drilling and production, increasing the ultimate recovery of the reserves, preventing waste, and protecting correlative rights.
- 21. Applicant states that those horizontal wells to be drilled under this Application will be drilled from two multi-well pads on the surface of the drilling unit, or on adjacent lands with consent of the landowner, without exception being granted by the Director. Further, Applicant will make good faith efforts to utilize existing well pads where feasible for the economic and efficient extraction of the underlying minerals.
- 22. Applicant states that, for any permitted wells to be drilled under this Application, the treated intervals of the wellbore should be not less than 460 feet from the outer boundary of the proposed drilling unit and not less than 150 feet from any other well or treated interval of a well producing from the Niobrara Formation, without exception being granted by the Director.

- 23. The granting of this Application is in accord with the Oil and Gas Conservation Act, found at §34-60-101, et seq., C.R.S., and the Commission rules.
- 24. That the names and addresses of the interested parties (owners within the proposed drilling unit) according to the information and belief of the Applicant are set forth in Exhibit B attached hereto. The Applicant shall submit a certificate of service for the Application within seven days as required by Rule 503.e.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing this Commission enter its order:

- A. Maintaining the approximate 80-acre drilling and spacing units established for Section 9, Township 6 North, Range 66 North, 6th P.M., for any existing well capable of producing oil, gas and associated hydrocarbons from the Niobrara Formation.
- B. Establishing an approximate 640-acre drilling and spacing unit for Section 9, Township 6 North, Range 66 North, 6th P.M., and authorizing the drilling of up to twenty (20) horizontal wells within the proposed unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- C. Requiring that any permitted wells to be drilled under this Application should be drilled from two multi-well pads, without exception being granted by the Director.
- D. Requiring that for any permitted wells to be drilled under this Application, the treated intervals of the wellbore should be not less than 460 feet from the outer boundary of the proposed unit and not less than 150 feet from any other well or treated interval of a well producing from the Niobrara Formation, without exception being granted by the Director.
- E. For such other findings and orders as the Commission may deem proper or advisable in the premises.
