VERIFIED APPLICATION

COMES NOW, Ward Petroleum Corporation ("Applicant"), by its attorneys, Lohf Shaiman Jacobs Hyman & Feiger PC, and submits it's Verified Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission"), for an order to establish, and pool all interests in, a 640-acre drilling and spacing unit in Section 15, Township 1 South, Range 67 West, 6th P.M, for horizontal wells to the Codell and/or Niobrara Formations, Wattenberg Field, Adams County, Colorado, and in support states:

- 1. Applicant is duly organized and authorized to conduct business in the State of Colorado.
- 2. Applicant owns leasehold interests in the following described lands in Adams County, Colorado, containing approximately 640-acres (hereinafter, the "Application Lands"):

Township 1 South, Range 67 West, 6th P.M. Section 15

- 3. On December 19, 1983, the Commission issued order No. 407-1 (amended March 29 2000) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell Formation, with the unit to be designated by the operator drilling the first well in each quarter section. The Order provided that the permitted well shall be located in the center of either 40-acre tract within the unit, with a tolerance of 200 feet in any direction, and the operator shall have the option to drill an additional well on the undrilled 40-acre tract in each 80-acre drilling and spacing unit. The Application Lands are subject to this Order for the Codell Formation.
- 4. On February 19, 1992, the Commission issued Order 407-87 (amended August 20, 1993), which, among other things, established 80-acre drilling and spacing units for production of oil, gas and assorted hydrocarbons from the Codell and Niobrara Formations, with the permitted well locations to be in accordance with Order No 407-1. The Application Lands are subject to this Order for the Codell and Niobrara Formations.
- 5. On April 27, 1988, the Commission adopted Rule 318A, the Greater Wattenberg Well Location Rule ("GWA Rule"), which among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all

Cretaceous Age Formations from the base of the Dakota Formation to the surface. This Rule supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of Greater Wattenberg Area wells. On December 5, 2005, Rule 318A was amended, among other things, to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address the drilling of horizontal wells. The Application Lands are subject to Rule 318A for the Codell and Niobrara Formations.

- 6. No wells have produced from the Codell or Niobrara Formations in said Section 15.
- 7. Applicant requests that the Application Lands be established as a 640-acre drilling and spacing unit for horizontal wells to the Codell and/or Niobrara Formations (the "Unit"). The requested spacing order should provide that up to twelve (12) optional horizontal wells may be drilled in the Unit to said Formations.
- 8. Applicant asserts that establishment of the Unit, and the provision for up to twelve (12) horizontal wells therein, will permit the economic and efficient drainage of the Codell and Niobrara Formations, will prevent waste, will not adversely affect correlative rights and will help assure the greatest ultimate recovery of oil and associated hydrocarbons from the Formations.
- 9. The requested order should further provide that the treated interval of any such horizontal well shall be no closer than 460-feet from the boundaries of the Unit, and no closer than one hundred fifty (150) feet from the treated interval of any well producing from the Codell and/or Niobrara Formations, without exception being granted by the Director of the Commission, and that all such horizontal wells must be drilled from no more than two pads in the Unit without exception being granted by the Director of the Commission.
- 10. A drilling and spacing unit of the size and shape specified above is not smaller than the maximum area which can be economically and efficiently drained by a single horizontal well to the Codell and/or Niobrara Formation in the Application Lands. The proposed wells can be developed in a manner consistent with protection of the environment, public health, safety and welfare.
- 11. Applicant proposes to drill and complete the horizontal Todd Creek Farms #15-2-3HC well to the Codell Formation and the horizontal Todd Creek Farms #15-2-4HN well to the Niobrara Formation (the "Wells") on the proposed Unit.
- 12. Applicant has been unable to obtain consent to voluntary pooling by all interest owners in the proposed Unit. As a result, Applicant requests that all interests in the proposed Unit be involuntarily pooled pursuant to C.R.S. §34-60-116, and with respect to the Wells, consenting parties be allowed to recover from any non-consenting owner's share of production the penalty costs provided in C.R.S.§ 34-60-116 (7) of the Colorado Oil and Gas Conservation Act.
- 13. At least thirty (30) days prior to the hearing on this Application, the Applicant will have sent all owners listed on **Exhibit A**, who have not previously consented to lease or otherwise participate in the drilling and completion of the Wells, an Authority for Expenditures (AFE) and/or supporting documents which contain all information required by Commission Rule 530.b., and in case of unleased mineral owners, an offer to lease which is reasonable based on the factors listed in Commission Rule 530.c. The Applicant also agrees to first comply with the requirements of Rule

530.b and c with respect to any subsequent well in the pooled Unit, prior to applying the cost recovery provisions of said statute.

- 14. Applicant anticipates that one or more of such owners will refuse or fail to respond to such offer to lease and/or to participate in the drilling, completion and operation of such Wells, and shall be deemed non-consenting parties under Commission Rule 530.b and c.
- 15. An order of the Commission pooling all interests in the Unit for production from the Codell and Niobrara Formations shall therefore be necessary in order to afford each owner of an interest in the Unit the opportunity to recover and receive its just and equitable share of the oil and/or gas from the common source of supply underlying the unit.
- 16. The granting of the requested order would not be prejudicial to the owners in the Unit and would protect correlative rights.
- 17. The requested pooling order should be effective as of the date of this Application or the date which costs specified by C.R.S. §34-60-116(7)(b) were first incurred by Applicant for the drilling of either of the Wells, whichever is first in time.
- 18. The names and addresses of those persons who own any interest in the mineral estate in the Application Lands, exclusive of overriding royalty interests, according to the information and belief of the Applicant are set forth on **Exhibit A**.
- 19. Copies of this Verified Application shall be served on all such owners within seven (7) days of the date of this Application, as required by Commission Rule 503.e.

REQUEST FOR HEARING AND ORDER

WHEREFORE, the Applicant, Ward Petroleum Corporation, respectfully requests that this matter be set for hearing in June 16 or 17, 2014, that notice be given as required by law, and upon such hearing this Commission enter its order:

- A. establishing a 640-acre drilling and spacing unit in the Application Lands for horizontal wells to the Codell and/or Niobrara Formations as requested above, under terms which are fair, reasonable and required by law
- B. pooling all interests in the Unit comprised of the Application Lands with respect to production of the Codell and Niobrara formations, and that such pooling Order be upon terms and conditions which are just and reasonable and afford to the owner of each interest the opportunity to recover or receive, without unnecessary expense, his just and equitable share of oil and gas; provide that production obtained from the pooled tract be allocated to each owner therein on the basis of the proportion that the number of mineral acres held by each owner in the Unit bears to the total number of mineral acres within the Unit; provide that with respect to the Wells the consenting parties be allowed to recover from any non-consenting owner's share of production the penalty costs as provided in C.R.S. § 34-60-116 (7)(b); and require the operator to provide each non-consenting interest owner in the Unit with monthly statement of costs incurred together with the quantity of oil and gas produced and proceeds realized, pursuant to C.R.S. §34-60-116(8).
