APPLICATION

COMES NOW SYNERGY RESOURCES CORPORATION (referred to herein as "Applicant"), by and through its undersigned attorneys, and makes application to the Colorado Oil and Gas Conservation Commission ("Commission"), for an order to pool all interests, including all unleased and/or nonconsenting interests, within four (4) designated wellbore spacing units for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations located on the following described lands:

Kelly Farms #A-4-3CHZ: (WSU #1)

Township 5 North, Range 66 West, 6th P.M.
Section 3: NW/4
Section 4: NE/4, E/2NW/4

Kelly Farms #A-4-3NHZ: (WSU #2)

Township 5 North, Range 66 West, 6th P.M.
Section 3: NW/4
Section 4: NE/4, E/2NW/4

Kelly Farms #22-4-3CHZ: (WSU #3)

Township 5 North, Range 66 West, 6th P.M.
Section 3: NW/4
Section 4: NE/4, E/2NW/4

Kelly Farms #12-4-3CHZ: (WSU #4)

Weld County, Colorado (referred to herein as the "Application Lands")

In support hereof, the Applicant states and alleges as follows:

1. Applicant is a Colorado corporation duly authorized to conduct business in the state of Colorado, and is a registered operator in good-standing with the Commission.

2. Applicant owns certain leasehold interests in the Application Lands requested for pooling.

3. On December 19, 1983, the Commission issued Order No. 407-1 (amended on March 29, 2000 in accordance with Order No. 407-17, entered November 18, 1985), which, among other things, established 80-acre drilling and spacing units for the production of oil and/or gas and associated hydrocarbons from the Codell Formation underlying certain lands, with the drilling and spacing unit to be designated by the operator drilling the first well in the quarter section, or by the Director of the Commission if the operator does not designate. The permitted well shall be located in the center of either 40-acre tract within the drilling and spacing unit with a tolerance of 200 feet in any direction. The operator shall have the option to drill an additional well on the undrilled 40-acre tract in each 80-acre drilling and spacing unit.

4. On February 19, 1992, the Commission issued Order No. 407-87 (amended August 20, 1993), which among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the permitted well locations in accordance with the provisions of Order No. 407-1.

5. On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A was amended to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was amended to, among other things, address drilling of horizontal wells. The lands encompassing the Application Lands are subject to Rule 318A, for the Codell and Niobrara Formations.

6. The Commission by Order No. 1 in cause No. 407 previously designated an 80-acre wellbore spacing unit for two wells, as described below, for the production of oil, gas, and associated hydrocarbons from the Codell Formation. In Order No. 407-10, the Commission amended Order No. 407-1 to include production from the Niobrara Formation in certain lands and to allow the downhole commingling of production from the Codell and Niobrara Formations. In Amended Order No. 407-87, the Commission expanded the scope of Niobrara Formation spacing and established 80-acre drilling and spacing with the Codell-Niobrara Formations underlying the Spacing Unit.

7. Pursuant to Rule 318A, Applicant designated four (4) 400-acre wellbore spacing units for the Kelly Farms #A-4-3CHZ Well, Kelly Farms #A-4-3NHZ Well, Kelly Farms #22-4-3CHZ Well, and Kelly Farms #12-4-3CHZ Well, (collectively "the Wells") respectively, for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations.

8. Applicant, pursuant to Commission Rule 530 and pursuant to the provisions of C.R.S. §34-60-116, seeks an order to pool all interests, including but not limited to, any nonconsenting interests, in the Kelly Farms #A-4-3CHZ Well for development and operation of the Codell Formation underlying the following designated 400-acre wellbore spacing unit:

9. Applicant, pursuant to Commission Rule 530 and pursuant to the provisions of C.R.S. §34-60-116, also seeks an order to pool all interests, including but not limited to, any nonconsenting interests, in the Kelly Farms #A-4-3NHz Well for development and operation of the Niobrara Formation underlying the following designated 400-acre wellbore spacing unit:

(WSU #2)

Section 4: NE/4, E/2NW/4

10. Applicant, pursuant to Commission Rule 530 and pursuant to the provisions of C.R.S. §34-60-116, also seeks an order to pool all interests, including but not limited to, any nonconsenting interests, in the Kelly Farms #22-4-3CHZ Well for development and operation of the Codell Formation underlying the following designated 400-acre wellbore spacing unit:

(WSU #3)

Section 3: NW/4

Section 4: NE/4, E/2NW/4

11. Applicant, pursuant to Commission Rule 530 and pursuant to the provisions of C.R.S. §34-60-116, also seeks an order to pool all interests, including but not limited to, any nonconsenting interests, in the Kelly Farms #12-4-3CHZ Well for development and operation of the Codell Formation underlying the following designated 400-acre wellbore spacing unit:

(WSU #4)

Township 5 North, Range 66 West, 6th P.M.

Section 3: NW/4

Section 4: NE/4, E/2NW/4

12. Applicant has commenced drilling the following four (4) Wells:

Kelly Farms A-4-3CHZ Well, API #05-123-38138 with a surface location of 2122' FNL and 2369' FWL of Section 4, Township 5 North, Range 66 West, 6th P.M., and a proposed bottomhole location of 1857' FNL and 2127' FWL in Section 3, Township 5 North, Range 66 West, 6th P.M.;

Kelly Farms #A-4-3NHZ Well, API #05-123-38136 with a surface location of 2130' FNL and 2330' FWL of Section 4, Township 5 North, Range 66 West, 6th P.M., and a proposed bottomhole location of 1636' FNL and 2133' FWL in Section 3, Township 5 North, Range 66 West, 6th P.M.;

Kelly Farms #22-4-3CHZ Well, API #05-123-38133 with a surface location of 2152' FNL and 2337' FWL of Section 4, Township 5 North, Range 66 West, 6th P.M., and a proposed bottomhole location of 2330' FNL and 2114' FWL in Section 3, Township 5 North, Range 66 West, 6th P.M.; and

Kelly Farms #12-4-3CHZ Well, API #05-123-38134 with a surface location of 2144' FNL and 2375' FWL of Section 4, Township 5 North, Range 66 West, 6th P.M., and a proposed bottomhole location of 2077' FNL and 2118' FWL in Section 3, Township 5 North, Range 66 West, 6th P.M.

13. Exhibit A attached hereto lists the mineral owners for the Application Lands together with their addresses. Applicant certifies that copies of the Application will be mailed to all persons owning an interest in the mineral estate of the Application Lands listed on Exhibit A within seven (7) days of the date hereof. Applicant further certifies that all unleased and/or nonconsenting mineral owners have been, or will be, offered a reasonable lease offer or to voluntarily participate in the drilling and completion of the Wells as required by Rule 530, at least thirty (30) days prior to the hearing on this Application. To date, however, not all of such mineral owners have elected to participate by agreeing to bear their respective proportionate shares of the costs and risks of drilling, completing and operating the Wells.

14. In order to prevent waste, protect correlative rights and foster the best interests of conservation of oil and gas resources, all interests in each WSU #1 through WSU #4, be pooled, for the orderly development of the Codell and Niobrara Formations, as applicable, including but not limited to any nonconsenting interests therein.

15. Applicant requests that the Commission's pooling order issued with respect to this Application be made effective as of the date of this Application, or the date that the costs specified in C.R.S. §34-60-116(7)(b)(II) are first incurred for the drilling of the Wells to the Codell and Niobrara formations.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing in September 2014, that notice thereof be given as required by law, and that upon such hearing this Commission enter its order:

A. Pooling all interests in the Kelly Farms #A-4-3CHZ Well and WSU #1, for the development and production for the Codell Formation.

B. Providing that the Commission's pooling order with respect to WSU#1 is made effective as of the date of the Application, or the date that the costs specified in C.R.S. §34-60-116(7)(b)(II) are first incurred for the drilling of the Kelly Farms #A-4-3CHZ Well from the Codell Formation, whichever is earlier.

C. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Kelly Farms #A-4-3CHZ Well are pooled by operation of statute, pursuant to C.R.S. §34-60-116(6) and (7), and made

subject to the cost recovery provisions thereof with respect to all wells drilled to develop the Codell Formation WSU #1.

D. Pooling all interests in the Kelly Farms #A-4-3NHZ Well and WSU #2, for the development and production for the Niobrara Formation.

E. Providing that the Commission's pooling order with respect to WSU#2 is made effective as of the date of the Application, or the date that the costs specified in C.R.S. §34-60-116(7)(b)(II) are first incurred for the drilling of the Kelly Farms #A-4-3NHZ Well from the Niobrara Formation, whichever is earlier.

F. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Kelly Farms #A-4-3NHZ Well are pooled by operation of statute, pursuant to C.R.S. §34-60-116(6) and (7), and made subject to the cost recovery provisions thereof with respect to all wells drilled to develop the Niobrara Formation WSU #2.

G. Pooling all interests in the Kelly Farms #22-4-3CHZ Well and WSU#3, for the development and production for the Codell Formation.

H. Providing that the Commission's pooling order with respect to WSU#3 is made effective as of the date of the Application, or the date that the costs specified in C.R.S. §34-60-116(7)(b)(II) are first incurred for the drilling of the Kelly Farms #22-4-3CHZ Well from the Codell Formation, whichever is earlier.

I. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Kelly Farms #22-4-3CHZ Well are pooled by operation of statute, pursuant to C.R.S. §34-60-116(6) and (7), and made subject to the cost recovery provisions thereof with respect to all wells drilled to develop the Codell Formation WSU #3.

J. Pooling all interests in the Kelly Farms #12-4-3CHZ Well and WSU #4, for the development and production for the Codell Formation.

K. Providing that the Commission's pooling order with respect to WSU #4 is made effective as of the date of the Application, or the date that the costs specified in C.R.S. §34-60-116(7)(b)(II) are first incurred for the drilling of the Kelly Farms #12-4-3CHZ Well from the Codell Formation, whichever is earlier.

L. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Kelly Farms #12-4-3CHZ Well are pooled by operation of statute, pursuant to C.R.S. §34-60-116(6) and (7), and made subject to the cost recovery provisions thereof with respect to all wells drilled to develop the Codell Formation WSU #4.

M. For such other findings and orders as the Commission may deem proper or advisable in this matter.
