VERIFIED APPLICATION

COMES NOW, Synergy Resources Corporation ("Applicant"), by its attorneys, Lohf Shaiman Jacobs Hyman & Feiger PC, and submits it's Verified Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission"), for an order to establish a 640-acre exploratory drilling and spacing unit in Section 36, Township 6 North, Range 58 West, 6th P.M, for horizontal wells to the Greenhorn Formation, in an unnamed field, Weld County, Colorado, and in support of its application states as follows:

- 1. Applicant is duly organized and authorized to conduct business in the State of Colorado (GOGCC Operator No. 10311).
- 2. Applicant owns leasehold interests in the following described lands in Weld County, Colorado, containing approximately 640-acres (hereinafter, the "Application Lands"):

Township 7 North, Range 59 West, 6th P.M. Section 36

- 3. The Application Lands are unspaced as to the Greenhorn Formation.
- 4. Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. Sections 36, Township 7 North, Range 59 West, 6th P.M. is subject to Rule 318.a. for the Greenhorn Formation.
 - 5. No wells have produced from the Greenhorn Formation in said Section 36.
- 6. Applicant desires to drill and complete horizontal wells to the Greenhorn Formation in the Application Lands.
- 7. Applicant requests that the Application Lands be established as an approximate 640-acre exploratory drilling and spacing unit for the drilling of horizontal wells to the Greenhorn Formation. The requested order should provide that up to two (2) horizontal wells may be drilled in the exploratory drilling and spacing unit to said Formation.

- 8. Applicant asserts that establishment of an approximate 640-acre exploratory drilling and spacing unit on the Application Lands, and the provision for up to two (2) horizontal wells therein, will permit the economic and efficient drainage of the Greenhorn Formation, will prevent waste, will not adversely affect correlative rights and will help assure the greatest ultimate recovery of oil, gas and associated hydrocarbons from the Greenhorn Formation.
- 9. The requested order should further provide that the treated interval of any such horizontal well shall be no closer than 600-feet from the boundaries of the unit, and no closer than 1,200 feet from the treated interval of any well producing from the Greenhorn Formation, without exception being granted by the Director of the Commission.
- 10. On information and belief, a drilling and spacing unit of the size and shape specified above is not smaller than the maximum area which can be economically and efficiently drained by a single horizontal well to the Greenhorn Formation in the Application Lands.
- 11. The proposed horizontal wells can be developed in a manner consistent with protection of the environment, public health, safety and welfare.
- 12. The names and addresses of the interested parties according to the information and belief of the Applicant are set forth on **Exhibit A** attached hereto and made a part hereof.

WHEREFORE, the Applicant, Synergy Resources Corporation, respectfully requests that this matter be set for hearing, that notice be given as required by law, and upon such hearing this Commission enter its order to establish a 640-acre exploratory drilling and spacing unit in the Application lands for horizontal wells to the Greenhorn Formation as requested above, under terms which are fair, reasonable and required by law.
