APPLICATION

BP America Production Company ("Applicant"), by and through its attorneys, Holland & Hart LLP and Dugan & Associates, P.C. as co-counsel, respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado (the "Commission") for an order pooling all interests for the development of the Fruitland Coal Formation for the Southern Ute 01-08 #1 Well (a/k/a Southern Ute GU 1-8 #1 Well or Southern Ute 1-8 #1 FC Well), API #05-067-06003, and the Southern Ute 01-08 #2 Well (a/k/a Southern Ute 1-8 #2 FC Well), API # (pending) ("Wells") on the following described lands:

Township 33 North, Range 7 West, N.M.P.M.  
Section 8: W $\frac{1}{2}$

La Plata County, Colorado ("Application Lands").

In support of its Application, Applicant states and alleges as follows:

1. Applicant, Operator No. 10000, is a corporation duly authorized to conduct business in the State of Colorado and is an operator in good standing with the Commission.
2. Applicant owns a leasehold interest in the Application Lands.
3. On June 17, 1988, the Commission issued Order No. 112-60, which, among other things, established 320-acre drilling and spacing units for the production of gas from the Fruitland coal seams underlying certain lands, including the Application Lands, with the permitted well located, when north of the north line of Township 32 North, in the NW $\frac{1}{4}$  and SE $\frac{1}{4}$  of the section, and south of the north line of Township 32 North, in the NE $\frac{1}{4}$  and SW $\frac{1}{4}$  of the section, and no closer than 900 feet to any outer boundary of the section, nor closer than 130 feet to any interior quarter section line.
4. On September 7, 1988, but effective as of August 15, 1988, the Commission issued Order No. 112-61, which, among other things, amended Order

No. 112-60 to allow for the drilling of the first well in the drilling and spacing unit for certain lands, including the Application Lands, not in the permitted location, but rather in the other quarter section, and established additional field rules for the Fruitland coal seams.

5. Effective as of December 17, 1990, the Commission issued Corrected Order No. 112-85, which, among other things, amended Order No. 112-61 and established additional field rules for the Fruitland coal seams in the 320-acre drilling and spacing units for certain lands, including the Application Lands.

6. On July 11, 2000, the Commission issued Order No. 112-157, which, among other things, amended Order Nos. 112-60, 112-61, and 112-85 to allow an optional additional well to be drilled for production of gas from the Fruitland coal seams in the 320-acre drilling and spacing units for certain lands, including the Application Lands, with the permitted well to be located in any undrilled quarter section no closer than 990 feet from the boundaries of the quarter section, nor closer than 130 feet to any interior quarter section line.

7. On July 10, 2006, the Commission issued Order No. 112-190, which, among other things, approved up to four (4) wells in established 320-acre drilling and spacing units for certain lands, including the Application Lands, with the permitted well to be located no closer than 660 feet from the unit boundary, for the production of gas and associated hydrocarbons from the Fruitland coal seams.

8. Applicant, pursuant to the provisions of C.R.S. § 34-60-116 and Commission Rule 530., seeks an order statutorily pooling all interests including, but not limited to, any nonconsenting interests, in the drilling and spacing unit comprised of the Application Lands, and authorizing the cost recovery provisions of C.R.S. § 34-60-116(7), as applicable, to each of the Wells, for the development and operation of the Fruitland Coal Formation.

9. Applicant requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Wells to the Fruitland Coal Formation on the Application Lands.

10. Applicant certifies that at least 35 days prior to the first hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease or participate in the drilling of the Wells, and will be provided with the information required by Rule 530.

11. Applicant also certifies that copies of this Application will be served within seven days of the date hereof on all persons owning any interest in the mineral estate of the tracts to be pooled as required by Rule 507.b(2). The list of such interested parties is attached hereto as Exhibit A.

12. In order to prevent waste and to protect correlative rights, all interests in the Application Lands should be statutorily pooled for the orderly development of the Fruitland Coal Formation.

WHEREFORE, Applicant requests that this matter be set for hearing at the next available opportunity; that notice be given as required by law; and that upon such hearing, the Commission enter its order:

A. Statutorily pooling all interests including, but not limited to, any nonconsenting interests, in the drilling and spacing unit comprised of the Application Lands.

B. Providing that the Commission's pooling order is made effective as of the earlier of the date of this Application, or the date that the costs specified in C.R.S. § 34-60-116(7)(b)(II) are first incurred for the drilling of the Wells to the Fruitland Coal Formation on the Application Lands.

C. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Southern Ute 01-08 #1 Well and the Southern Ute 01-08 #2 Well are statutorily pooled pursuant to C.R.S. § 34-60-116 and made subject to the cost recovery provisions thereof.

D. For such other findings and orders as the Commission may deem proper or advisable in this matter.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, notice be given as required by law, and that upon such hearing, the Commission enter its order consistent with Applicant's request as set forth above.

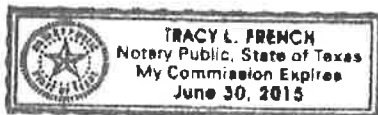

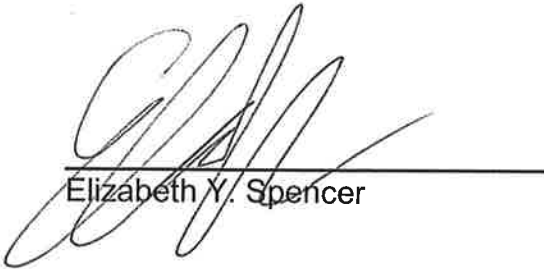
