NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On October 19, 1981, the Commission issued Order No. 232-23, which among other things, established 320-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the J Sand Formation, and allowed up to two wells to be drilled within each 320-acre drilling and spacing unit. Section 36, Township 1 North, Range 68 West, 6th P.M. is subject to this Order for the J Sand Formation.

On December 19, 1983, the Commission issued Order No. 407-1 (amended March 29, 2000), which among other things, established 80-acre drilling and spacing units for the production of oil and/or gas and associated hydrocarbons from the Codell Formation underlying certain lands with the unit to be designated by the operator drilling the first well in the quarter section. The permitted well shall be located in the center of either 40-acre tract within the unit with a tolerance of 200 feet in any direction. The operator shall have the option to drill an additional well on the undrilled 40-acre tract in each 80-acre drilling and spacing unit. Section 36, Township 1 North, Range 68 West, 6th P.M. is subject to this Order for the Codell Formation.

On September 16, 1991, the Commission issued Order Nos. 467-8 and 407-75, which among other things, established 160-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the J Sand Formation. Section 1, Township 1 South, Range 68 West, 6th P.M. is subject to this Order for the J Sand Formation.

On February 19, 1992, the Commission issued Order No. 407-87 (amended August 20, 1993), which among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations underlying certain lands, with the permitted well locations in accordance with the provisions of Order No. 407-1. Section 36, Township 1 North, Range 68 West, 6th P.M. is subject to this Order for the Codell and Niobrara Formations.

On April 27, 1998, the Commission adopted Rule 318A., which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from the base of the Dakota Formation to the surface. Pursuant to Rule 318A.k., Rule 318A. supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of Greater Wattenberg Area wells. Rule 318A.d. provides that an operator may allocate production to any drilling and spacing unit with respect to a particular Cretaceous Age Formation consistent with the provisions of Rule 318A. Section 36, Township 1 North, Range 68 West, 6th P.M. and Section 1, Township 1 South, Range 68 West, 6th P.M. are subject to Rule 318A., for the production of oil, gas and associated hydrocarbons from the J Sand, Codell and Niobrara Formations.

On June 27, 2011, the Commission issued Order No. 407-434, which among other things, approved a variance from Rule 318A.f. to authorize a total of up to nine producing completions, for the production of oil, gas and associated hydrocarbons from the J Sand, Codell and Niobrara Formations. Section 36, Township 1 North, Range 68 West, 6th P.M. is subject to this Order for the J Sand, Codell and Niobrara Formations.

On June 27, 2011, the Commission issued Order No. 407-435, which among other things, approved a variance from Rule 318A.f. to authorize a total of up to ten producing completions, for the production of oil, gas and associated hydrocarbons from the J Sand, Codell and Niobrara Formations. Section 36, Township 1 North, Range 68 West, 6th P.M. is subject to this Order for the J Sand, Codell and Niobrara Formations.

On August 8, 2011, the Commission amended Rule 318A to allow for the drilling of horizontal wells within the GWA area and the designation of horizontal well wellbore spacing units pursuant to Rule 318A(l).a.(4)D. The amended Rule 318A was effective on September 30, 2011. Section 36, Township 1 North, Range 68 West, 6th P.M. and Section 1, Township 1 South, Range 68 West, 6th P.M. are subject to Rule 318A(l).a.(4)D. for the J Sand, Codell and Niobrara Formations.

On February 15, 2012, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant"), by its attorneys, filed with the Commission pursuant to § 34-60-116 C.R.S., a verified application ("Application") for an order to pool all interests in an approximate 160-acre designated wellbore spacing unit for the below-described lands ("Application Lands"), to accommodate the Northglenn State 37-36 Well (API No. 05-123-34475), for the development and operation of the J Sand, Codell and Niobrara Formations, effective as of the

earlier of the date of the Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b)(II) were first incurred for the drilling of the well, and to subject any nonconsenting interests to the cost recovery provisions of C.R.S. § 34-60-116(7):

Section 36: S½SE¼ (Weld County, Colorado)

Township 1 South, Range 68 West, 6th P.M.
Section 1: N½NE¼ (Adams County, Colorado)

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado (Commission) under § 34-60-105 C.R.S.; 2) specific powers granted pursuant to § 34-60-106 C.R.S.; 3) the Colorado Administrative Procedures Act at § 24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than April 2, 2012, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 2, 2012.** Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by **April 2, 2012, the Applicant may request that an administrative hearing be scheduled beginning April 2, 2012.** In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
