NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On October 1, 2012, the Commission entered Order No. 535-206 which, among other things, established an approximate 1280-acre exploratory drilling and spacing unit, and approved up to eight horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. Sections 19 and 20, Township 7 North, Range 59 West, 6th P.M. are subject to this Order for the Niobrara Formation.

On November 15, 2012, the Commission entered Order No. 535-213 which, among other things, pooled all interests in an approximate 1280-acre exploratory drilling and spacing unit established for Sections 19 and 20, Township 7 North, Range 59 West, 6th P.M., to accommodate the Loga n 2H Well (API No. 05-123-36316) only, for the development and operation of the Niobrara Formation.

On December 13, 2012, Condor Energy Technology LLC ("Condor"), by its attorneys, filed with the Commission pursuant to §34-60-116 C.R.S., a verified application ("Application") for an order to affirm Order No. 535-213 pooling all interests in an approximate 1280-acre drilling and spacing unit established for the below-described lands ("Application Lands"), for the development and operation of the Niobrara Formation, effective as of the earlier of the date of this Application, or the date that any of the costs specified in C.R.S. § 34-60-116(7)(b)(II) were first incurred for the drilling of the Logan 2H Well, and to subject any nonconsenting interests to the cost recovery provisions of C.R.S. §34-60-116(7):

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of

the application or to intervene on the application should file with the Commission a written protest or intervention no later than January 28, 2013, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of January 28, 2013. Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by January 28, 2013, the Applicant may request that an administrative hearing be scheduled during the week of January 28, 2013. In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
