NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On September 19, 2011, the Commission entered Order No. 535-70 which, among other things, established two approximate 640-acre drilling and spacing units, and approved up to two horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. Section 25, Township 8 North, Range 60 West, 6th P.M. is subject to this Order for the Niobrara Formation.

On October 31, 2011, the Commission entered Order No. 535-91 which, among other things, established two approximate 640-acre drilling and spacing units, and approved up to two horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. Sections 26 and 35, Township 8 North, Range 60 West, 6th P.M. are subject to this Order for the Niobrara Formation.

On July 9, 2012, the Commission entered Order No. 535-187 which, among other things, pooled all interests in an approximate 640-acre drilling and spacing unit established for Section 35, Township 8 North, Range 60 West, 6th P.M., for the development and operation of the Niobrara Formation.

On July 9, 2012, the Commission entered Order No. 535-188 which, among other things, pooled all interests in an approximate 640-acre drilling and spacing unit established for Section 25, Township 8 North, Range 60 West, 6th P.M., for the development and operation of the Niobrara Formation.

On July 9, 2012, the Commission entered Order No. 535-189 which, among other things, pooled all interests in an approximate 640-acre drilling and spacing unit established for Section 26, Township 8 North, Range 60 West, 6th P.M., for the development and operation of the Niobrara Formation.

On November 15, 2012, the Commission entered Order No. 535-219 which, among other things, approved up to four horizontal wells within each of three approximate 640-acre drilling and spacing units, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the horizontal wellbore to be no closer than 600 feet from the unit boundaries, and no closer than 600 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director. Sections 25, 26 and 35, Township 8 North, Range 60 West, 6th P.M. are subject to this Order for the Niobrara Formation.

On January 24, 2013, Carrizo Oil & Gas, Inc. ("Carrizo" or "Applicant"), by its attorneys, filed with the Commission pursuant to §34-60-116 C.R.S., a verified application ("Application") for an order to approve up to a total of six horizontal wells within each of three approximate 640-acre drilling and spacing units established for the below-described lands ("Application Lands"), for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the horizontal wellbore to be no closer than 600 feet from the unit boundaries, and no closer than 600 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director:

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105 C.R.S.; 2) specific powers granted pursuant to §34-60-106 C.R.S.; 3) the State Administrative Procedure Act at §24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than March 11, 2013, briefly stating the basis of the protest or intervention. Such interested party shall, at the same time, serve a copy of the protest or intervention to the person filing the application. An original and 13 copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of March 11, 2013.** Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in

accordance with these rules. In accordance with the practices of the Commission, should no protests or interventions be filed in this matter by **March 11, 2013, the Applicant may request that an administrative hearing be scheduled beginning March 11, 2013.** In the alternative, pursuant to Rule 511., if the matter is uncontested, the applicant may request, and the Director may recommend approval on the basis of the merits of the verified application and the supporting exhibits.
