APPLICATION

On May 29, 2014, Great Western Operating Company, LLC ("Great Western" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 314-acre wellbore spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Taoka KF 01-021HN Well (API No. Pending).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992, Order No. 407-87 established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations, within the permitted well locations in accordance with Order No. 407-1.
- On July 29, 2013, Order No. 407-831, which established two approximate 320-acre drilling and spacing units and approved up to six horizontal wells within each unit for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formation.
