APPLICATION

On May 29, 2014, Great Western Operating Company, LLC ("Great Western" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in an approximate 320-acre designated wellbore spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Postle IC 11-382HN Well (API No. 05-123-38970).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992, Order No. 407-87 established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations, within the permitted well locations in accordance with Order No. 407-1.
- On July 29, 2013, Order No. 407-833 established an approximate 640-acre drilling and spacing unit and approved up to 12 horizontal wells within the unit, for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formation.
- On March 17, 2014, Order No. 407-967 pooled all interests in an approximate 640-acre designated wellbore spacing unit established for Section 11, Township 3 North, Range 68 West, 6th P.M., and subjected any nonconsenting interests to the cost

recovery provisions of §34-60-116(7)(b), C.R.S., for the development and operation of the Codell-Niobrara Formation.

- On April 28, 2014, Order No. 407-1012 pooled all interests in an approximate 480-acre designated wellbore spacing unit for the drilling of the Reynolds Cattle Company 30N-23HZ Well (API No. 05-123-39135).

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 14, 2014.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
