APPLICATION

On May 29, 2014, Kerr-McGee Oil & Gas Onshore LP ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 400-acre designated wellbore spacing unit established for the Application Lands, for the development and operation of the Codell Formation; and
- 2) Subject all interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that the costs specified in §34-60-116(7), C.R.S., were first incurred for the drilling of the Mulga 28C-23HZ Well (API No. 05-123-39255).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992, Order No. 407-87 established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations, within the permitted well locations in accordance with Order No. 407-1.
