- 1) Pool all interests, including, but not limited to, any nonconsenting interests and leased mineral interests, in an approximate 480-acre wellbore spacing unit established for the Application Lands, for the development and operation of the Codell Formation, effective as of the date of the Application; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Cruickshank 1C-24HZ Well (API No. 05-123-39498).
