1) Pool all interests, including, but not limited to, any nonconsenting interests and leased mineral interests, in two approximate 480-acre wellbore spacing units established for the Application Lands, for the development and operation of the Codell and Niobrara Formations, effective as of the date of the Application; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Barefoot 31C-25HZ Well (API No. 05-123-39191) and the Barefoot 30N-25HZ Well (API No. 05-123-39231).
