APPLICATION

On May 29, 2014, Red Hawk Petroleum LLC ("Red Hawk" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests, including previously unnoticed interests, in an approximate 1,280-acre drilling and spacing unit established by Order No. 535-51, for the development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Pergamos 10-1H Well (API No. Pending).

PRIOR RULES AND ORDERS

- On August 8, 2011, Order No. 535-51 vacated the approximate 640-acre drilling and spacing unit; established four approximate 1280-acre drilling and spacing units and nine approximate 640-acre drilling and spacing units; and approved one horizontal well within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- On June 17, 2014, Order No. 535-489 approved an additional seven horizontal wells, for a total of up to eight horizontal wells, within an approximate 640-acre drilling and spacing unit established for Section 10, Township 7 North, Range 60 West, 6th P.M. for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- On June 17, 2014, Order No. 535-498 pooled all interests within an approximate 640-acre drilling and spacing unit, for the development and operation of the Niobrara Formation, to accommodate the drilling of the Pergamos 10-1H Well (API No. Pending).

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105 C.R.S.; 2) specific powers granted pursuant to §34-60-106 C.R.S.; 3) the State Administrative Procedures Act at §24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:
