**NOTICE OF HEARING**

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

Pursuant to Rule 522.c., the Colorado Oil and Gas Conservation Commission ("Commission" or "COGCC") Staff will apply to the Commission at its September 15-16, 2014, hearing for an Order Finding Violation ("OFV") against Petro Mex Resources ("Petro Mex") (Operator No. 10059).

Petro Mex is the operator of record of the Government 6 Well (API No. 05-045-06779) and Government 9 Well (API No. 05-045-06772) in Garfield, County. On June 17, 2014, Order 1V-469 required Petro Mex to pay \$23,000 by July 23, 2014 and complete corrective actions by July 16, 2014. Petro Mex has violated this Order by not paying the penalty or completing the corrective actions.

On August 19, 2014, Commission Staff issued a Notice of Alleged Violation ("NOAV") No. 400667326 to Petro Mex citing violations of Rule 523.a. (Procedure for Assessing Fines) of the COGCC Rules of Practice and Procedure, 2 CCR 404-1 ("Rule" or "Rules") for failure to comply with Order 1V-469.

COGCC staff requests that Petro Mex be found in violation of the Rule cited above and assessed a penalty pursuant to Rule 523, and other relief as authorized by law.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado (Commission) under § 34-60-105 C.R.S.; 2) specific powers granted pursuant to § 34-60-106 C.R.S.; 3) the Colorado Administrative Procedures Act at § 24-4-105 C.R.S.; and 4) the Commission's 500 Series Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:



Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to protect the health, safety and welfare of the public and to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

In accordance with Rule 509., any interested party desiring to protest the granting of the application or to intervene on the application should file with the Commission a written protest or intervention no later than August 29, 2014, briefly stating the basis of the protest or intervention. One electronic, one original and two copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of August 29, 2014. Pursuant to Rule 503.g., if a party who has received notice under Rule 503.b. wishes to receive further pleadings in the above-referenced matter, that party must file a protest or intervention in accordance with these rules.
