APPLICATION

On June 27, 2014, Great Western Operating Company LLC ("Great Western") sent notices of 318A proposals to establish designated horizontal wellbore spacing units ("WSUs") and 14 proposed horizontal wells ("Proposed Wells") for the above-described Application Lands ("Proposal").

On July 24, 2014, Extraction Oil & Gas, LLC ("Extraction") filed a timely objection pursuant to Rule 318A.e.(6), objecting to Great Western's proposed wells and designated horizontal wellbore spacing units ("Objection"). The Objection alleges the following deficiencies in the Proposal:

- Great Western does not own a mineral interest in the mineral estate through which the wellbores of the Proposed Wells will pass;
- 2) Great Western's Proposed Wells and WSUs will cause waste;
- Great Western's Proposed Wells and WSUs will adversely affect the correlative rights of Extraction in the Application Lands;
- Great Western's Proposed Wells will cause a trespass to Section 2, Township 6 North, Range 67 West, 6th P.M.; and
- Great Western's Proposed Wells and WSUs will unnecessarily cause cumulative surface impacts.

On August 20, 2014, Extraction filed an Application for Hearing on Rule 318A Objection ("Application") pursuant to Rule 503.b.(10).
