#### **APPLICATION**

On July 17, 2014, WPX Energy Rocky Mountain, LLC ("WPX" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,770-acre exploratory drilling unit for the Application Lands, for the production of gas and associated hydrocarbons from the Mancos (including the Sego Sandstone), Niobrara, Frontier, Mowry, and Dakota Formations (collectively "Deep Formations");
  - 2) Approve up to 60 horizontal, vertical or directional wells within the unit; and
- 3) Require the productive interval of the wellbore to be located no closer than 600 feet from the unit boundaries, and no closer than 300 feet from the productive interval of any other wellbore located in the unit, without exception being granted by the Director.
- 4) Applicant requests that the proposed wells be located on be drilled from a new, common, or existing well pad from the surface either on the Application Lands or on adjacent lands with consent of the landowner, from no more than one pad per quarter quarter section (or lots or parcels approximately equivalent thereto).

### APPLICABLE RULES AND ORDERS

 Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
