- 1) Pool all interests in an approximate 160-acre designated horizontal wellbore spacing unit established for the Application Lands, for the development and operation of the Codell Formation, effective as of the date of the Application; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Bohrer 2F-19H-E368 Well (API No. 05-123-38447).
