On July 17, 2014, Noble Energy, Inc. ("Noble" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 640-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the McClellan LG09-72HN Well (API No. 05-123-36972).

- On September 19, 2011, Order No. 535-69 established 40 approximate 640-acre drilling and spacing units for Townships 7 through 9 North, Ranges 59 and 61 West, 6th P.M., and approved two horizontal wells within each unit, for the production of gas and associated hydrocarbons from the Niobrara Formation.
