- 1) Pool all interests in an approximate 1280-acre drilling and spacing unit established for the Application Lands, effective as of the date of the Application, for the development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the initial permitted horizontal Niobrara Formation well drilled within the Application Lands and any subsequent horizontal Niobrara Formation wells authorized by the Commission (API No. Pending).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 22, 2011 (corrected on April 4, 2013), Order Nos. 407-779 and 535-4 established 74 approximate 640-acre drilling and spacing units and approved one horizontal well for each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- On June 17, 2013, Order No. 407-798 established two approximate 640-acre drilling and spacing units for Section 22, Township 4 North, Range 62 West, 6th P.M., and approved up to 16 horizontal wells within one of the units and up to four horizontal wells within the other unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formations.

 On March 17, 2014, Order No. 407-949, among other things, vacated an approximate 640-acre drilling and spacing unit established by Order Nos. 407-779 and 535-4 for Section 15, Township 4 North, Range 62 West, 6th P.M., established an approximate 1,280-acre drilling and spacing unit, and approved a total of up to 16 horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation..
