On August 28, 2014, Encana Oil & Gas (USA) Inc., acting by and through its authorized agent, Encana Services Company, Ltd. ("Encana" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in two approximate 480-acre designated horizontal wellbore spacing units established for the Application Lands, effective as of the date of the Application, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Grant Hurt 1A-14H-G268 Well (API No. 05-123-38088) and Grant Hurt 1B-14H-G268 Well (API No. 05-123-38089).
