On August 28, 2014, Ursa Ope rating Company LLC ("Ursa" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Confirm Order No. 513-8 as to certain mineral interest owners that were not properly noticed under the original application.
- 2) Pool all interests in an approximate 320-acre drilling and spacing unit established for the Application Lands, effective as of the date of the Application, for the development and operation of the Williams Fork and lles Formations; and
- 3) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the McLin A33A-12-06-92 Well (API No. Pending), McLin A33B-12-06-92 Well (API No. Pending), McLin A33D-12-06-92 Well (API No. Pending), McLin A34B-12-06-92 Well (API No. Pending), McLin A34B-12-06-92 Well (API No. Pending), McLin A34C-12-06-92 Well (API No. Pending), and McLin A34D-12-06-92 Well (API No. Pending).

- On February 22, 2010, Order Nos. 513-6 and 523-6 established a 320-acre drilling and spacing unit for the Application Lands, and approved up to one well per 10 acres within the unit, for the production of oil, gas and associated hydrocarbons from the Williams Fork and Iles Formations.
- On April 28, 2014, Order No. 513-8 pooled all interests in the 320-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Williams Fork and Iles Formations, and subjected nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S. for the Frei A23 Well, the Frei A24 Well, the Frei A20 Well, the Frei A19 Well and the Frei A14 Well.
