- 1) Pool all interests in five approximate 633.721-acre designated horizontal wellbore spacing units established for the Application Lands, effective as of the date of the Application, for the development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the the Colt A13-645 well (API No. 05-123-40910), the Colt A13-648 well (API No. 05-123-40907), Colt A13-650 well (API No. 05-123-40931), the Colt A13-652 well (API No. 05-123-40928), and the Colt A13-655 well (API No. 05-123-40908).
