On December 22, 2014, Noble Energy, Inc. (Operator No. 100322) ("Noble" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 235.371-acre designated horizontal wellbore spacing unit established for the Application Lands, effective as of the date of the Application, for the development and operation of the Codell Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Colt A13-638 well (API No. 05-123-40919).



Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of February 13, 2015. Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
