1) Pool all interests in three approximate 640-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Colt A13-611 Well (API No. 05-123-40918), the Colt A13-613 Well (API No. 05-123-40909), or the Colt A13-615 Well (API No. 05-123-40920).


