APPLICATION

On December 23, 2014, Whiting Oil and Gas Corporation (Operator No. 96155) ("Whiting" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate two approximate 640-acre drilling and spacing units established by Order Nos. 535-42 and 535-174 for Sections 18 and 19, Township 9 North, Range 57 West, 6<sup>th</sup> P.M.;
- 2) Vacate Order No. 535-193 for Sections 18 and 19, Township 9 North, Range 57 West, 6<sup>th</sup> P.M.;
- 3) Establish an approximate 1080-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations;
- 4) Approve up to 32 horizontal wells within the unit; and
- 5) Require the productive interval of the wellbore to be located no closer than 100 feet from the unit boundaries, and no closer than 100 feet from the productive interval of any other wellbore located in the unit.
- 6) Applicant states that the proposed wells shall be drilled from no more than six wellpads within the unit.

- On June 27, 2011, the Commission entered Order No. 535-42 which established eight approximate 640-acre drilling and spacing units and approved one horizontal

well within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

- On July 9, 2012, the Commission entered Order No. 535-174 which established three approximate 640-acre drilling and spacing units and approved up to four horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation.
- On August 20, 2012, the Commission entered Order No. 535-193 which approved up to four horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105 C.R.S.; 2) specific powers granted pursuant to §34-60-106 C.R.S.; 3) the State Administrative Procedures Act at §24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of February 13, 2015. Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
