NOTICE OF HEARING

APPLICATION

On December 23, 2014, Whiting Oil and Gas Corporation (Operator No. 96155) ("Whiting" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate an approximate 640-acre drilling and spacing unit established by Order No. 535-42 for Sections 8, 17, and 20, Township 9 North, Range 57 West, 6th P.M.;
- 2) Vacate an approximate 960-acre drilling and spacing unit established by Order No. 535-555 for the S $\frac{1}{2}$ of Section 8 and all of Section 17, Township 9 North, Range 57 West, 6th P.M.;
- 3) Establish an approximate 1200-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations;
- 4) Approve up to 32 horizontal wells within the unit; and
- 5) Require the productive interval of the wellbore to be located no closer than 100 feet from the unit boundaries, and no closer than 100 feet from the productive interval of any other wellbore located in the unit.
- 6) Applicant requests that the wells are drilled from no more than eight well pads within the unit.

- On June 27, 2011, the Commission entered Order No. 535-42 which established eight approximate 640-acre drilling and spacing units and approved one horizontal well within each unit for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. Sections 8, 17, and 20, Township 9 North, Range 57 West, 6th P.M. are subject to this Order for the Niobrara Formation.
- On April 28, 2014, the Commission entered Order No. 535-481 which vacated two approximate 640-acre drilling and spacing units established by Order No. 535-42 and established four approximate 960-acre drilling and spacing units allowing for up to 16 horizontal wells within each unit for production of oil, gas and associated hydrocarbons from the Niobrara Formation. The S½ of Section 8, Township 9 North, Range 57 West, 6th P.M. is subject to this Order for the Niobrara Formation.
- On October 27, 2014, the Commission entered Order No. 535-555, which vacated one approximate 640-acre drilling and spacing unit established by Order No. 535-42 for Section 17, Township 9 North, Range 57 West, 6th P.M., and established one approximate 960-acre drilling and spacing unit, allowing for up to 32 horizontal wells within the unit for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations. The S½ of Section 8 and all of Section 17, Township 9 North, Range 57 West, 6th P.M. are subject to this Order for the Niobrara and Codell Formations.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105 C.R.S.; 2) specific powers granted pursuant to §34-60-106 C.R.S.; 3) the State Administrative Procedures Act at §24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:



Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of February 13, 2015. Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
