On January 30, 2015, Anadarko E&P Onshore LLC, Operator No. 2800 ("Anadarko" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Approve an additional five horizontal wells, for a total of six horizontal wells, within the approximate 1280-acre drilling and spacing unit established by Order No. 421-57 for the Application Lands, for production of oil, gas and associated hydrocarbons from the Codell Formation; and
- 2) Require the treated intervals of the wellbore should be not less than 600 feet from the unit boundaries with an inter-well setback of not less than 600 feet from the treated interval of a well producing from the Codell Formation, without exception being granted by the Director.
- 3) Applicant requests that the proposed wells be drilled from the surface of the drilling unit.

APPLICABLE RULES AND ORDERS

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
- On January 26, 2015, the Commission entered Order No. 421-57 which, among other things, established drilling and spacing units for certain lands, including the Application

Lands, and approved one horizontal well for the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation.
