APPLICATION

On February 5, 2015, Ward Petroleum Corporation (Operator No. 10359) ("Ward" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S.; for an order to:

- 1) Pool all interests in an approximate 640-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date the costs specified under §34-60-116(7), C.R.S. were first incurred for the drilling of the SHL Ward Riverdale #14-4-12HC and the SHL Ward Riverdale #14-4-11HN wells

On March 23, 2015, Applicant requested a continuance of this matter to the May, 2015 hearing and the issuance of an Amended Notice of Hearing.

- On June 17, 2014, the Commission issued Order 407-1038, which, among other things, established the Application Lands as an approximate 640-acre drilling and spacing unit for production of oil, gas and assorted hydrocarbons from horizontal wells to the Codell and Niobrara Formations.
- On June 17, 2014, the Commissioner entered Order No. 407-1076 which, among other things, pooled all interests in the unit; and subjected all nonconsenting interests to the cost recovery penalties provided by C.R.S. §34-60-116(7) for the Todd Creek Farms #14-4-4HN and the Todd Creek Farms #14-4-3HN wells.


