APPLICATION

On February 20, 2015, Anadarko E&P Onshore LLC, Operator No. 2800 ("Anadarko" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Approve an additional five horizontal wells, for a total of six horizontal wells, within an approximate 1290-acre drilling and spacing unit established by Order No. 535-564, for Sections 18, 19 and 30, Township 12 North, Range 63 West, 6<sup>th</sup> P.M., for production of oil, gas and associated hydrocarbons from the Codell Formation.
- 2) Require the productive interval of the wellbore to be located no closer than 600 feet from the unit boundaries, and no closer than 600 feet from the productive interval of any other wellbore located in the unit, without exception being granted by the Director.

- On October 27, 2014, the Commission entered Order No. 535-564, which established an approximate 1290-acre drilling and spacing unit for the Application Lands, and approved one horizontal well within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation.
