NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION LANDS

Township 11 North, Range 65 West, 6<sup>th</sup> P.M.

Section 2:     Lots 1 and 2 (approximately 155.80 acres),

Township 12 North, Range 65 West, 6<sup>th</sup> P.M.

APPLICATION

On March 12, 2015, Anadarko E&P Onshore LLC, Operator No. 2800 ("Anadarko" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1)     Establish an approximate 1,276-acre drilling and spacing unit for Section 2, Township 11 North, Range 65 West, 6<sup>th</sup> P.M., and Section 35, Township 12 North, Range 65 West, 6<sup>th</sup> P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 2)     Approve up to seven horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 3)     Approve an additional five horizontal wells, for a total of six horizontal wells, within an approximate 1275-acre drilling and spacing unit established by Order No. 535-581, for production of oil, gas, and associated hydrocarbons from the Codell Formation; and
- 4)     Require the productive interval of the wellbore to be located no closer than 600 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, without exception being granted by the Director.

## APPLICABLE RULES AND ORDERS

- Rule 318.a. of the Commission Rules provides a well to be drilled 2,500 feet or greater shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply, unless authorized by the Commission upon hearing.
- On October 27, 2014, the Commission entered Order No. 535-581 which established an approximate 1,275-acre drilling and spacing unit for the Application Lands, and approved one horizontal well within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105 C.R.S.; 2) specific powers granted pursuant to §34-60-106 C.R.S.; 3) the State Administrative Procedures Act at §24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of May 4, 2015.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
