APPLICATION

On March 19, 2015, SWN Production Company, LLC, Operator No. ("SWN" or "Applicant"), by its attorneys, filed with the Commission pursuant to §34-60-116, C.R.S., a verified application ("Application") for an order to:

1) Vacate an approximate 2537.82-acre unconventional resource unit established by Order Nos. 540-25 for Sections 17, 18, 19 and 20, Township 8 North, Range 90 West, 6<sup>th</sup> P.M., for the production of oil, gas and associated hydrocarbons from Mancos and Niobrara Formations; and

2) Vacate Order No. 540-36 which pooled all interests in an approximate 2537.82-acre unconventional resource unit established for Sections 17, 18, 19 and 20, Township 8 North, Range 90 West, 6<sup>th</sup> P.M. for the development and operation of the Mancos and Niobrara Formations.

- On October 28, 2013, the Commission entered Order No. 540-25 which established an approximate 2537.82-acre unconventional resource unit, for the production of oil, gas and associated hydrocarbons from Mancos and Niobrara Formations, and approved an appropriate number of vertical, directional or horizontal wells, in order to efficiently and economically recover the oil, gas and associated hydrocarbons from the proposed unit.
- On October 28, 2013, the Commission entered Order No. 540-36 which pooled all interests within an approximate 2537.82-acre unconventional resource unit established for the Application Lands, to accommodate four initial wells, for the

development and operation of Mancos and Niobrara Formations.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 6, 2015.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
