APPLICATION

On March 19, 2015, Cirque Resources LP, Operator No. 10470 ("Cirque" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate the approximate 634.56-acre drilling and spacing unit established by Order No. 535-610 for Section 22, Township 12 North, Range 66 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Codell Formation;
- 2) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell Formation;
 - 3) Approve up to four horizontal wells within the unit; and
- 4) Require the productive interval of the wellbore to be located no closer than 300 feet from the unit boundaries, and no closer than 660 feet from the productive interval of any other wellbore located in the unit, without exception by the Director.

 Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.

 On December 15, 2014, the Commission entered Order No. 535-610 which established an approximate 640-acre drilling and spacing unit for Section 22, Township 12 North, Range 66 West, 6th P.M., and approved up to four horizontal wells for the Codell Formation for the unit.
