APPLICATION

On May 15, 2015, Extraction Oil & Gas LLC (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in three approximate 640-acre designated horizontal wellbore spacing units established for the Application Lands for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Thornton #1 Well (API No. 05-123-40272) (WSU #1), the Thornton #2 Well (API No. 05-123-40255) (WSU #2), and the Thornton #3 Well (API No. 05-123-40257) (WSU #3).
