APPLICATION

On May 21, 2015, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in an approximate 315-acre designated horizontal wellbore spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Bernhardt 6O-243 Well (API No. 05-123-40493).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), Order No. 407-87 established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the permitted well locations in accordance with the provisions of Order No. 407-1.

- On July 28, 2014, the Commission entered Order No. 407-2014, which among other things, approved the request for an order to pool all interests in three approximate 640-acre designated wellbore spacing units established for portions of the Application Lands, for the development and operation of the Niobrara Formation.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 6, 2015. Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
