2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Waag #3 Well (API No. 05-123-40344) (WSU #1), the Waag #4 Well (API No. 05-123-40345) (WSU #2), the Waag #5 Well (API No. 05-123-40341) (WSU #3), the Waag #6 Well (API No. 05-123-40356) (WSU #4), the Waag #7 Well (API No. 05-123-40364) (WSU #5), the Waag #8 Well (API No. 05-123-40357) (WSU #6), the Waag #9 Well (API No. 05-123-40353) (WSU #7), the Waag #10 Well (API No. 05-123-40362) (WSU #8), and the Waag #11 Well (API No. 05-123-40360) (WSU #9).


