2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Waag #15 Well (API No. 05-123-40358) (WSU #1), the Waag #16 Well (API No. 05-123-40363) (WSU #2), the Waag #17 Well (API No. 05-123-40365) (WSU #3), the Waag #18 Well (API No. 05-123-40354) (WSU #4), the Waag #19 Well (API No. 05-123-40351) (WSU #5), the Waag #20 Well (API No. 05-123-40346) (WSU #6), the Waag #21 Well (API No. 05-123-40350) (WSU #7), the Waag #22 Well (API No. 05-123-40348) (WSU #8), and the Waag #23 Well (API No. 05-123-40349) (WSU #9).



Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 6, 2015. Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
