APPLICATION

On May 21, 2015, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in two approximate 560-acre designated horizontal wellbore spacing units, for the development and operation of the Codell and Niobrara Formations.
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Kodak North FD 28-082HC Well (API No. 05-123-39385) to the Codell Formation, or the Kodak North FD 28-119HN Well (API No. 05-123-39347) to the Niobrara Formation.

PRIOR RULES AND ORDERS

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations, with the permitted well locations in accordance with the provisions of Order No. 407-1.
- On April 28, 2014, the Commission entered Order No. 407-1025 which pooled all interests in nine approximate 320-acre wellbore spacing units for the development and operation of the Codell and/or Niobrara Formations. Order No. 407-1025 has since been vacated.

- On July 28, 2014, the Commission entered Order No. 407-1090 which pooled all interests in an approximate 480-acre wellbore spacing unit established for portions of the Application Lands, for the development and operation of the Niobrara Formation.
- On March 2, 2015, the Commission entered Order No. 407-1238 which vacated the pooling provisions entered by Order No. 407-1025, and pooled all interests in seven approximate 400-acre to 640-acre designated wellbore spacing units, including portions of the Application Lands, for the development and operation of the Codell and Niobrara Formations.



One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 6, 2015.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
