APPLICATION

On May 21, 2015, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant") filed a verified application pursuant to § 34-60-116 C.R.S. for an order to:

- 1) Pool all interest in two approximate 480-acre horizontal wellbore spacing units designated for the Application Lands for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of § 34-60-116(7), C.R.S. effective as of the earlier of the date of the Application, or the drilling of the Tedford 29N-28HZ well, (API No. Pending) in WSU No. 1 and the Tedford 29C-28HZ well, (API No. Pending) in WSU No. 2.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), Order No. 407-87 established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the permitted well locations in accordance with the provisions of Order No. 407-1.



One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 6, 2015.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
