On May 21, 2015 (**Amended July 17, 2015**), Bayswater Exploration & Production, LLC (Operator No. 10261) ("Bayswater" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 329.93-acre drilling and spacing unit established for the Application Lands, for the development and operation of the **Codell and Niobrara Formations**; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Holton I-12HN well (API No. 05-123-39509) and the Holton J-12HN well (API No. 05-123-39507).
