APPLICATION

On July 16, 2015, Kerr-McGee Oil & Gas Onshore LP, Operator No. 47120 ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in four approximate 200-acre to 400-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Thermo 15C-33HZ Well (API No. Pending) (WSU #1), the Thermo 15N-33HZ Well (API No. Pending)

(WSU #2), the Thermo 37N-33HZ Well (API No. Pending) (WSU #3), and the Thermo 37C-33HZ Well (API No. Pending) (WSU #4).

Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
