<u>APPLICATION</u>

Extraction Oil & Gas, LLC ("Extraction" or "Applicant"), Operator No. 10459, by its attorneys, Welborn Sullivan Meck & Tooley, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission" or "COGCC") for an order pooling all interests in eight approximate 560-acre wellbore spacing units ("WSU") established for the S½ of Section 16 and the E½SW¼ and SE¼ of Section 17, Township 5 North, Range 65 West, 6th P.M., Weld County, Colorado for the development and production of oil, gas and associated hydrocarbons from the Codell Formation in WSU Nos. 2, 5 and 8, and the Niobrara Formation in WSU Nos. 1, 3, 4, 6 and 7. In support thereof, the Applicant states as follows:

- 1. Applicant is a limited liability company duly authorized to conduct business in the State of Colorado.
- 2. Applicant owns a leasehold interest in the following lands ("Application Lands"):

Township 5 North, Range 65 West, 6th P.M.

Section 16: S1/2

Section 17: E1/2SW1/4, SE1/4

Weld County, Colorado.

A reference map of the Application Lands is attached hereto.

1. Rule 318A.a.(4)D. provides, in relevant part, that where a drilling and spacing unit does not exist for a horizontal well, the horizontal wellbore spacing unit shall be comprised of the governmental quarter-quarter sections in which the wellbore lateral penetrates the productive formation as well as any governmental quarter-quarter sections that are located less than four hundred sixty (460) feet from the portion of the wellbore lateral that penetrates the productive zone regardless of section or quarter section lines. Rule 318A.a.(4)D. further provides that a horizontal

wellbore spacing unit may overlap portions of another horizontal wellbore spacing unit or other wellbore spacing unit designated in accordance with subsection a.(4)C. The Application Lands are subject to this Rule.

- 2. Applicant plans to drill and complete the following wells in individual wellbore spacing units covering the Application Lands in the corresponding formation:
 - a. **WSU No. 1:** Vetting 15 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,994 feet FNL and 568 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Niobrara Formation;
 - b. **WSU No. 2:** Vetting 16 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,991 feet FNL and 591 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Codell Formation;
 - c. **WSU No. 3:** Vetting 17 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,998 feet FNL and 615 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Niobrara Formation;
 - d. **WSU No. 4:** Vetting 18 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,985 feet FNL and 639 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Niobrara Formation;
 - e. **WSU No. 5:** Vetting 19 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,982 feet FNL and 663 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Codell Formation;
 - f. **WSU No. 6:** Vetting 20 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,979 feet FNL and 687 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Niobrara Formation;
 - g. **WSU No. 7:** Vetting 21 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,975 feet FNL and 710 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Niobrara Formation; and
 - h. **WSU No. 8:** Vetting 22 well (API No. Pending). Estimated spud date third quarter 2016. Located 1,972 feet FNL and 734 feet FWL, Section 15, Township 5 North, Range 65 West, 6th P.M. to produce oil, gas and associated hydrocarbons from the Codell Formation.

Hereinafter, the "Wells."

- 3. Pursuant to the relevant provisions of Section 34-60-116(6) & (7), C.R.S., and COGCC Rule 530, Applicant seeks an order pooling all interests in the Application Lands for the development and operation of the Codell Formation in WSU Nos. Nos. 2, 5 and 8, and the Niobrara Formation in WSU Nos. 1, 3, 4, 6 and 7.
- 4. Applicant certifies that, at least thirty-five (35) days prior to the date of the scheduled protest deadline for this Application, each owner which Applicant was able to locate, not already leased or voluntarily pooled, will be provided with the well proposals and information required by Rule 530 and tendered a reasonable offer to lease (if an unleased mineral owner), or participate and bear costs associated with the drilling and completion of the Wells.
- 5. Applicant requests that a pooling order be entered as a result of this Application and that it be made effective as of the earlier of the date of this Application, or the date costs specified in Section 34-60-116(7)(b)(II), C.R.S., are first incurred for the drilling of the wells the Codell Formation in WSU Nos. Nos. 2, 5 and 8, and the Niobrara Formation in WSU Nos. 1, 3, 4, 6 and 7.
- 6. The granting of this Application would be in accord with the Oil and Gas Conservation Act, found at Section 34-60-101, *et seq.*, C.R.S., and Commission rules.
- 7. The names and addresses of the interested parties (persons who own an interest in the mineral estate of the tracts to be pooled, except owners of overriding royalty interest) are attached hereto and marked Exhibit A. Applicant certifies that copies of this Application will be served on all locatable interested parties within seven (7) days of the date hereof, as required by Commission Rule 507.b.(2), and that at least thirty-five (35) days prior to the date of the scheduled protest deadline for this Application, each such owner not already leased or voluntarily pooled will be offered the opportunity to lease, or to participate in the drilling of the Wells, and will be provided with the information required by Rule 530.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing this Commission enter its order:

- A. Pooling all interests in the Application Lands for the development and operation of the Codell Formation in WSU Nos. 2, 5 and 8, and the Niobrara Formation in WSU Nos. 1, 3, 4, 6 and 7.
- B. Providing that the pooling order is made effective as of the date of this Application, or the date that the costs specified in Section 34-60-116(7)(b)(II), C.R.S., are first incurred for the drilling of a well in the Codell Formation in WSU Nos. Nos. 2, 5 and 8, and the Niobrara Formation in WSU Nos. 1, 3, 4, 6 and 7 on the Application Lands, whichever is earlier;
- C. Providing that the interests of any owners, with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the authorized wells, are pooled by operation of statute, pursuant to Section 34-60-116(7), C.R.S., and made subject to the cost recovery provisions thereof;

D. For such other findings and orders as the Commission may deem proper or advisable in the premises.


