APPLICATION

Extraction Oil & Gas, LLC, Operator No. 10459 ("Applicant" or "Extraction"), by and through its attorneys, Welborn Sullivan Meck & Tooley, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order vacating Order Nos. 467-8 and 407-87 as they pertain to Sections 7 and 18, Township 1 South, Range 68 West, 6th P.M., establishing an approximate 1,850-acre drilling and spacing unit and establishing well location rules applicable to the drilling of wells and producing of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations covering certain lands in Broomfield County, Colorado. In support of its Application, Applicant states as follows:

1. Applicant is a limited liability company duly authorized to conduct business in Colorado.
2. Applicant owns leasehold interests in the following lands ("Application Lands"):
Township 1 South, Range 68 West, 6th P.M.
Section 7: All
Section 18: All

Broomfield County, Colorado

A reference map of the Application Lands is attached hereto.

3. On September 16, 1991, the Commission entered Order No. 467-8, which established that the location of all wells drilled to the "J" Sand Formation underlying areas subject to Cause No. 407 and at a legal location pursuant to Rule 318 or Cause No. 467 shall be automatically approved, without hearing, as a legal location for production from the Codell or

Niobrara Formations, provided the following conditions are met: (a) the size of the voluntary unit for production from the Codell Formation is either (i) 160-acres or (ii) the same size as the unit for production from the "J" Sand Formation, with the unit for the Codell Formation not less than that prescribed by Cause No. 407; and (b) the location of the wellbore in the Codell Formation is not less than 920 horizontal feet from any existing wellbore in the Codell Formation capable of producing from such Formation and, in addition, not less than 920 horizontal feet from any proposed, permitted well for which the Codell Formation is the identified objective formation. Section 18, Township 1 South, Range 68 West, 6th P.M. is subject to this Order.

4. On February 19, 1992, the Commission entered Order No. 407-87 (Amended), which established 80-acre drilling and spacing units for the production of oil and/or gas from the Codell-Niobrara Formations underlying lands in Adams, Boulder, Jefferson, Larimer, and Weld Counties. The Order allows for dual completion and downhole commingling as to both oil and gas in the Codell-Niobrara Formations. Section 7, Township 1 South, Range 68 West, 6th P.M. is subject to this Order.

5. The Codell and Niobrara Formations are common sources of supply under the Application Lands.

6. To promote efficient drainage of the Codell and Niobrara Formations within the Application Lands and to avoid waste, the Commission should vacate Order Nos. 467-8 and 407-87 as they pertain to the Application Lands and establish an approximate 1,850-acre drilling and spacing unit covering the Application Lands described below for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations:

Township 1 South, Range 68 West, 6th P.M.

Section 7: All

Section 18: All

7. Applicant is requesting to drill and complete up to one (1) horizontal well in the approximate 1,850-acre drilling and spacing unit described above, with the option to drill and complete up to a total of twenty (20) horizontal wells in the unit for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations with the surface location to be located at a legal location in the above described drilling and spacing unit or on adjacent lands. Applicant further requests that the treated interval of each wellbore be no closer than 150 feet from the treated interval of any other wellbore producing from the Codell and Niobrara Formations, and no closer than 100 feet from a unit boundary unless such boundary abuts or corners lands for which the Commission has not at the time of the drilling permit application granted the right to locate the treated interval of the wellbore no closer than 100 feet from a unit boundary. If the Commission has not at the time of the drilling permit application granted to the owners of the adjacent or cornering lands the right to locate the treated interval of the wellbore no closer than 100 feet from a unit boundary, then the treated interval of the wellbore shall be located no closer than 300 feet from the unit boundary, without exception being granted by the Director.

8. The Livingston #43-07 well (API #05-014-09435) was spud on October 11, 2002, in the NESE, Section 7, Township 1 South, Range 68 West, 6th P.M., pursuant to Order NO. 467-8 for the development and production of, *inter alia*, the Niobrara and Codell Formations. This

well is currently producing. Applicant is the Operator of this well and Applicant plans to plug and abandon the well pursuant to the Commission Rules as soon as production is established in the requested drilling and spacing unit.

9. The Hellerstein #2-18 well (API #05-014-09065) was completed on June 3, 1992, in the SESE, Section 18, Township 1 South, Range 68 West, 6th P.M., for the development and production of, *inter alia*, the Niobrara and Codell Formations. This well is currently producing. Applicant is the Operator of this well and Applicant plans to plug and abandon the well pursuant to the Commission Rules as soon as production is established in the requested drilling and spacing unit.

10. Applicant requests authority to drill only those wells necessary to determine the well density which allows the most efficient drainage of the Codell and Niobrara Formations, prevents waste, does not adversely affect correlative rights, and assures the greatest ultimate recovery of oil, gas and associated hydrocarbon substances from the Codell and Niobrara Formations. The drilling and spacing units are not smaller than the maximum area that can be economically and efficiently drained by the proposed wells in such drilling and spacing unit. Applicant further maintains that wells drilled in the drilling and spacing unit will have no adverse effect on correlative rights of adjacent owners.


