APPLICATION

Extraction Oil & Gas, Inc., Operator No. 10459 ("Applicant" or "Extraction"), by and through its attorneys, Welborn Sullivan Meck & Tooley, P.C., respectfully submits this **Amended** Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order (1) vacating nine designated Rule 318A horizontal wellbore spacing units and Order No. 407-1121 and (2) establishing an approximate 1,600 1,280-acre drilling and spacing unit and establishing well location rules applicable to the drilling of wells and producing of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations covering certain lands in Adams County, Colorado. In support of its Application, Applicant states as follows:

- 1. Applicant is a corporation duly authorized to conduct business in Colorado and is a registered operator in good standing with the Commission.
- 2. Applicant owns a majority leasehold interest in the following lands ("Application Lands") and is an owner, as defined by Commission Rules and the Colorado Oil and Gas Conservation Act, with standing to file and maintain this Application:

Section 10: E½
Section 11: All
Section 12: W½ All

Township 1 South, Range 65 West, 6th P.M. Section 7: S½

Adams County, Colorado

A reference map of the Application Lands is attached hereto.

- 3. On February 19, 1992, the Commission entered Order No. 407-87, August 20, 1993, which established 80-acre drilling and spacing units for the production of oil and/or gas from the Codell-Niobrara Formations underlying lands in Adams, Boulder, Jefferson, Larimer, and Weld Counties. The Order allows for dual completion and downhole commingling as to both oil and gas in the Codell-Niobrara Formations.
- 4. On April 27, 1988, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule, which was amended on August 8, 2011 to, among other things, address the drilling of horizontal wells and requires that a horizontal wellbore spacing unit must include any governmental quarter-quarter section that are located less than 460' from the completed interval of the wellbore lateral. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of the Greater Wattenberg Area. The Rule does not, however, prohibit the establishment of drilling and spacing units within the Greater Wattenberg Area.
- 5. On October 27, 2014, the Commission entered Order No. 407-1121, which approved Extraction Oil & Gas Inc.'s request for an order to pool all interests in nine approximate 320-acre designated Rule 318A horizontal wellbore spacing units established by Extraction for the E½W½, W½E½ of Section 12, Township 1 South, Range 66 West, 6th P.M., effective as of the date of the Application, for development and operation of the Codell and Niobrara Formations and subjected all nonconsenting parties to the cost recovery provisions of Section 34-60-116(7), C.R.S., for the Duck Club #1 Well (API No. 05-001-09821), the Duck Club #2 Well (API No. 05-001-09820), the Duck Club #3 Well (API No. 05-001-09818), the Duck Club #4 Well (API No. 05-001-09819), the Duck Club #5 Well (API No. 05-001-09817), the Duck Club #6 Well (API No. 05-001-09814), the Duck Club #7 Well (API No. 05-001-09822), the Duck Club #8 Well (API No. 05-001-09815), and the Duck Club #9 Well (API No. 05-001-09816) (the "Duck Club WSUs"). Section 12, Township 1 South, Range 66 West, 6th P.M. of the Application Lands is subject to the Duck Club WSUs and Order No. 407-1121. None of the Duck Club wells have been drilled and the APDs have expired.
- 6. The Codell and Niobrara Formations are a common source of supply under the Application Lands.
- 7. To promote efficient drainage of the Codell and Niobrara Formations within the Application Lands and to avoid waste, Applicant requests that the Commission (1) vacate the Duck Club WSUs and Order No. 407-1121 and (2) establish an approximate 1,600 1,280-acre drilling and spacing unit covering the Application Lands described below for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations:

Section 10: E½
Section 11: All
Section 12: W½ All

Township 1 South, Range 65 West, 6th P.M. Section 7: S½

- 8. Applicant is requesting to drill and complete one (1) horizontal well in the approximate 1,600 1,280-acre drilling and spacing unit described above, with the option to drill and complete up to a total of forty-four (44) twelve (12) horizontal wells in the unit for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations with the surface location to be located at a legal location in the above-described drilling and spacing unit or on adjacent lands. Applicant further requests that the treated interval of each wellbore be no closer than 150 feet from the treated interval of any other wellbore producing from the Codell and Niobrara Formations, and no closer than 460 feet from a unit boundary, without exception being granted by the Director.
- 9. Applicant requests authority to drill only those wells necessary to determine the well density which allows the most efficient drainage of the Codell and Niobrara Formations, prevents waste, does not adversely affect correlative rights, and assures the greatest ultimate recovery of oil, gas and associated hydrocarbon substances from the Codell and Niobrara Formations. The drilling and spacing unit is not smaller than the maximum area that can be economically and efficiently drained by the proposed wells in such drilling and spacing unit. Applicant further maintains that wells drilled in the drilling and spacing unit will have no adverse effect on correlative rights of adjacent owners.
- 10. Applicant states that the wells be drilled from one well pad located within the unit or from a legal location on adjacent lands, without exception granted by the Director. Applicant further states that it has secured a Surface Use Agreement for the surface location and, by the time this matter is heard in January 2018, Applicant will have submitted all required permitting to Adams County for approval of its surface location as well as Forms 2 and 2A to the Commission. Upon approval of its Adams County permits and Forms 2 and 2A, Applicant plans to immediately proceed with development of the Application Lands.
- 11. The names and addresses of the interested parties according to the information and belief of the Applicant are set forth in <u>Exhibit A</u> attached hereto and made a part hereof, and the undersigned certifies that copies of the original Application shall be served on each interested party as required by Rule 503.e. and 507.b.(1).
