AMENDED APPLICATION

Whiting Oil and Gas Corporation ("Applicant"), Operator No. 96155, by and through its attorneys, Welborn Sullivan Meck & Tooley, P.C., respectfully submits this **Amended** Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order vacating Order Nos. 535-268 and 535-630 insofar as they apply to the Application Lands, establishing one (1) approximate 1,280-acre drilling and spacing unit, and establishing well location rules applicable to the drilling of wells and producing of oil, gas and associated hydrocarbons from the **Carlile, Fort Hays,** Codell and Niobrara Formations covering certain lands in Weld County, Colorado. In support of its Application, Applicant states as follows:

1. Applicant owns leasehold interests in the following lands ("Application Lands"):

Township 11 North, Range 58 West, 6th P.M.

Section 27: All Section 34: All

A reference map of the Application Lands is attached hereto.

2. Rule 318.a. provides that a well drilled in excess of 2,500 feet in depth shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same source of supply, unless authorized by order of the Commission upon hearing. The Application Lands are subject to this rule for the Carlile, Fort Hays, and Codell Formation. The N½ of Section 27, Township 11 North, Range 58 West, 6th P.M., are subject to this rule for the Niobrara Formation.

- 3. On February 11, 2013, the Commission entered Order No. 535-268 which established ten approximate 960-acre drilling and spacing units and approved up to four horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the horizontal wellbore to be no closer than 600 feet from the unit boundaries, and no closer than 150 feet from the treated interval of any other wellbore located in the unit. The S½ of Section 27 and all of Section 34, Township 11 North, Range 58 West, 6th P.M., are subject to this Order for the Niobrara Formation.
- 4. On January 26, 2015, the Commission entered Order No. 535-630 which approved an additional 12 horizontal wells, for a total of up to 16 horizontal wells within the existing approximate 960-acre drilling and spacing unit for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the productive interval of the wellbore to be located no closer than 300 feet from the unit boundaries, and no closer than 300 feet from the productive interval of any other wellbore located in the unit, without exception. The S½ of Section 27 and all of Section 34, Township 11 North, Range 58 West, 6th P.M., are subject to this Order for the Niobrara Formation.
- 5. The Niobrara Formation in the area of the Application Lands is defined as the stratigraphic equivalent of the interval between 5,777 feet (top of the Niobrara) and 6,101 feet (base of the Niobrara) as found in the Walker #3 Well located in Section 31, Township 10 North, Range 58 West, 6th P.M., Weld County, Colorado. The Niobrara Formation is a common source of supply under the Application Lands.
- 6. The Codell Formation in the area of the Application Lands is defined as the stratigraphic equivalent of the interval between 6,101 feet (top of Codell) and 6,115 feet (base of Codell) as found in the Walker #3 Well located in Section 31, Township 10 North, Range 58 West, 6th P.M., Weld County, Colorado. The Codell Formation is a common source of supply under the Application Lands.
- 7. Applicant has drilled, tested and completed wells in the Codell and Niobrara Formations on lands in close proximity to the Application Lands.
- 8. To promote efficient drainage of the **Carlile, Fort Hays**, Codell and Niobrara Formations within the Application Lands and to avoid waste, the Commission should vacate Order No. 535-268 (insofar as it pertains to the Application Lands) and Order No. 535-630 (in its entirety) and establish one (1) approximate 1,280-acre drilling and spacing unit covering the Application Lands described below for production of oil, gas and associated hydrocarbons from the **Carlile, Fort Hays**, Codell and Niobrara Formations:

Township 11 North, Range 58 West, 6th P.M.

Section 27: All Section 34: All

9. Applicant is requesting to drill and complete one (1) horizontal well in the approximate 1,280-acre drilling and spacing unit described above, with the option to drill and complete up to a total of thirty-two (32) horizontal wells in the unit for production of oil, gas and associated hydrocarbons from the **Carlile**, **Fort Hays**, Codell and Niobrara Formations in the

Application Lands with the surface location to be located at a legal location in the above described drilling and spacing unit or on adjacent lands. Applicant further requests that the treated interval of each wellbore be no closer than 100 feet from the treated interval of any other wellbore producing from the **Carlile, Fort Hays,** Codell and/or Niobrara formations, and no closer than 100 feet from a unit boundary unless such boundary abuts or corners lands for which the Commission has not at the time of the drilling permit application granted the right to locate the treated interval of the wellbore no closer than 100 feet from a unit boundary. If the Commission has not at the time of the drilling permit application granted to the owners of the adjacent or cornering lands the right to locate the treated interval of the wellbore no closer than 100 feet from a unit boundary, then the treated interval of the wellbore shall be located no closer than 300 feet from the unit boundary, without exception being granted by the Director.

- 10. Applicant requests authority to drill only those wells necessary to determine the well density which allows the most efficient drainage of the **Carlile**, **Fort Hays**, Codell and Niobrara Formations, prevents waste, does not adversely affect correlative rights, and assures the greatest ultimate recovery of oil, gas and associated hydrocarbon substances from the **Carlile**, **Fort Hays**, Codell and Niobrara Formations. The proposed drilling and spacing unit is not smaller than the maximum area that can be economically and efficiently drained by the authorized wells in such drilling and spacing unit. Applicant further maintains that wells drilled in the above-proposed drilling and spacing unit will have no adverse effect on correlative rights of adjacent owners.
- 11. Applicant further requests that the wells are drilled from no more than four (4) well pads within the unit.
- 12. The names and addresses of the interested parties according to the information and belief of the Applicant are set forth in Exhibit A attached hereto and made a part hereof, and the undersigned certifies that copies of this <a href="Amended Application shall be served on each interested party within seven days after filing of the original application as required by Rules 503.e, 507.b.1, and 507.b.5.
