APPLICATION

Petro Operating Company LLC ("Applicant"), Operator No. 10583, by and through its attorneys, Welborn Sullivan Meck & Tooley, P.C., respectfully submits this Application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission" or "COGCC"), pursuant to Commission Rule 503.b.(2), for an order vacating Commission Order No. 407-1911 and pooling all interests in an approximate 1,241-acre drilling and spacing unit covering certain lands in Weld and Adams Counties, Colorado for development and production from the Codell and Niobrara Formations. In support thereof, the Applicant states as follows:

1. Applicant is a limited liability company duly authorized to conduct business in the State of Colorado and is an operator in good standing with the Commission.
2. Applicant owns leasehold interests in the following lands ("Application Lands") and therefore has standing to file this application pursuant to Commission Rule 503.b.(2):

Township 1 South, Range 66 West, 6th P.M.

Section 3: All
Section 10: W½

Township 1 North, Range 66 West, 6th P.M.

Section 34: S½

Weld and Adams Counties, Colorado.

A reference map of the Application Lands is attached hereto.

3. On February 19, 1992, the Commission entered Order No. 407-87 (Amended), which established 80-acre drilling and spacing units for the production of oil and/or gas from the Codell-Niobrara Formations underlying lands in Adams, Boulder,

Jefferson, Larimer, and Weld Counties. The Order allows for dual completion and downhole commingling as to both oil and gas in the Codell-Niobrara Formations.

4. On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule (amended on December 5, 2005 by Order 1R-100) which established locations to drill to any Cretaceous formation and allowed for commingling production from any formation between the base of the Dakota formation and the surface.

5. On August 8, 2011 the Commission further amended Rule 318A to, among other things, address the drilling of horizontal wells and require that a horizontal wellbore spacing unit must include any governmental quarter-quarter section located less than 460 feet from the completed interval of the wellbore lateral. The Rule does not, however, prohibit the establishment of drilling and spacing units within the Greater Wattenberg Area.

6. On March 20, 2017, the Commission issued Order No. 407-1908, which established an approximate 960-acre drilling and spacing unit covering Section 3, Township 1 South, Range 66 West, 6th , P.M., and the S ½ of Section 34, Township 1 North Range 66 West, 6th P.M., and approved a total of 24 horizontal wells for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations. The Application Lands, except the W½ of Section 10, are subject to this Order for the Codell and Niobrara Formations.

7. On March 20, 2017, the Commission issued Order No. 407-1911, which pooled all interests in the approximate 960-acre drilling and spacing unit established by Order No. 407-1908 for the development and production of the Codell and Niobrara Formations and subjected all nonconsenting owners to the cost recovery provisions of Section 34-60-116(7), C.R.S. for the Homestead 1 through 24 wells. The Application Lands, except the W½ of Section 10, are subject to this Order for the Codell and Niobrara Formations.

8. On October 12, 2017, Applicant filed an application in Docket No. 171200833 to vacate Order No. 407-1908 and establish an approximate 1,241-acre drilling and spacing unit covering the Application Lands and approve up to 24 horizontal wells within the unit for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations. The application in Docket No. 171200833 is unopposed and scheduled to be heard on the Commission's consent agenda at the December 11-12, 2017 hearing.

9. In May, 2017, Verdad Resources, LLC drilled, but has not completed, eight (8) horizontal wells in the E½ of the 960-acre unit approved by Order No. 407-1908: Homestead 15 well (API No. 05-123-44638); Homestead 16 well (API No. 05-123-44636); Homestead 17 well (API No. 05-123-44643); Homestead 18 well (API No. 05-123-44627); Homestead 19 well (API No. 05-123-44631) ; Homestead 20 well (API No. 05-123-44624); Homestead 21 well (API No. 05-123-44646); and Homestead 22 well (API No. 05-123-44644) (collectively, the "Homestead Wells"). Applicant has conferred with Verdad and the parties agree that when production is established from

these wells, production will be allocated based on the proposed 1,241-acre drilling and spacing unit subject to Docket No. 171200833.

10. Applicant and/or Verdad Resources, LLC has drilled or intends to drill the following wells in the Application Lands:

(collectively, the "Homestead Wells").

11. Pursuant to the relevant provisions of Section 34-60-116(6) & (7), C.R.S., and COGCC Rule 530, Applicant seeks an order pooling all interests in the Application Lands for the development and operation of the Codell and Niobrara Formations.

12. Applicant requests that a pooling order be entered as a result of this Application and that it be made effective as of the earlier of the date of this Application, or the date costs specified in Section 34-60-116(7)(b)(II), C.R.S., are first incurred for the drilling of each of the Homestead Wells.

13. The granting of this Application would be in accord with the Oil and Gas Conservation Act, found at Section 34-60-101, *et seq.*, C.R.S., and Commission rules.

14. The names of the interested parties (persons who own an interest in the mineral estate of the tracts to be pooled, except owners of overriding royalty interest) are attached hereto and marked Exhibit A. Applicant certifies that copies of this Application will be served on all locatable interested parties within seven (7) days of the date hereof, as required by Commission Rule 507.b(2), that lease offers have already been provided to all interested parties.

15. Applicant certifies that, at least thirty-five (35) days prior to the date of the scheduled protest deadline for this Application, each owner which Applicant was able to locate, not already leased or voluntarily pooled, will be provided with the well proposal and information required by Rule 530 and tendered a reasonable offer to lease (if an unleased mineral owner), or participate and bear costs associated with the drilling and completion of the Wells.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing, that notice be given as required by law and that upon such hearing this Commission enter its order:

A. Pooling all interests in the Application Lands for the development and operation of the Codell and Niobrara Formations.

B. Providing that the pooling order is made effective as of the date of this Application, or the date that the costs specified in Section 34-60-116(7)(b)(II), C.R.S., are first incurred for the drilling of the Homestead Wells.

C. Providing that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the authorized wells are pooled by operation of statute, pursuant to Section 34-60-116(7), C.R.S., and made subject to the cost recovery provisions thereof.

D. For such other findings and orders as the Commission may deem proper or advisable in the Application Lands.



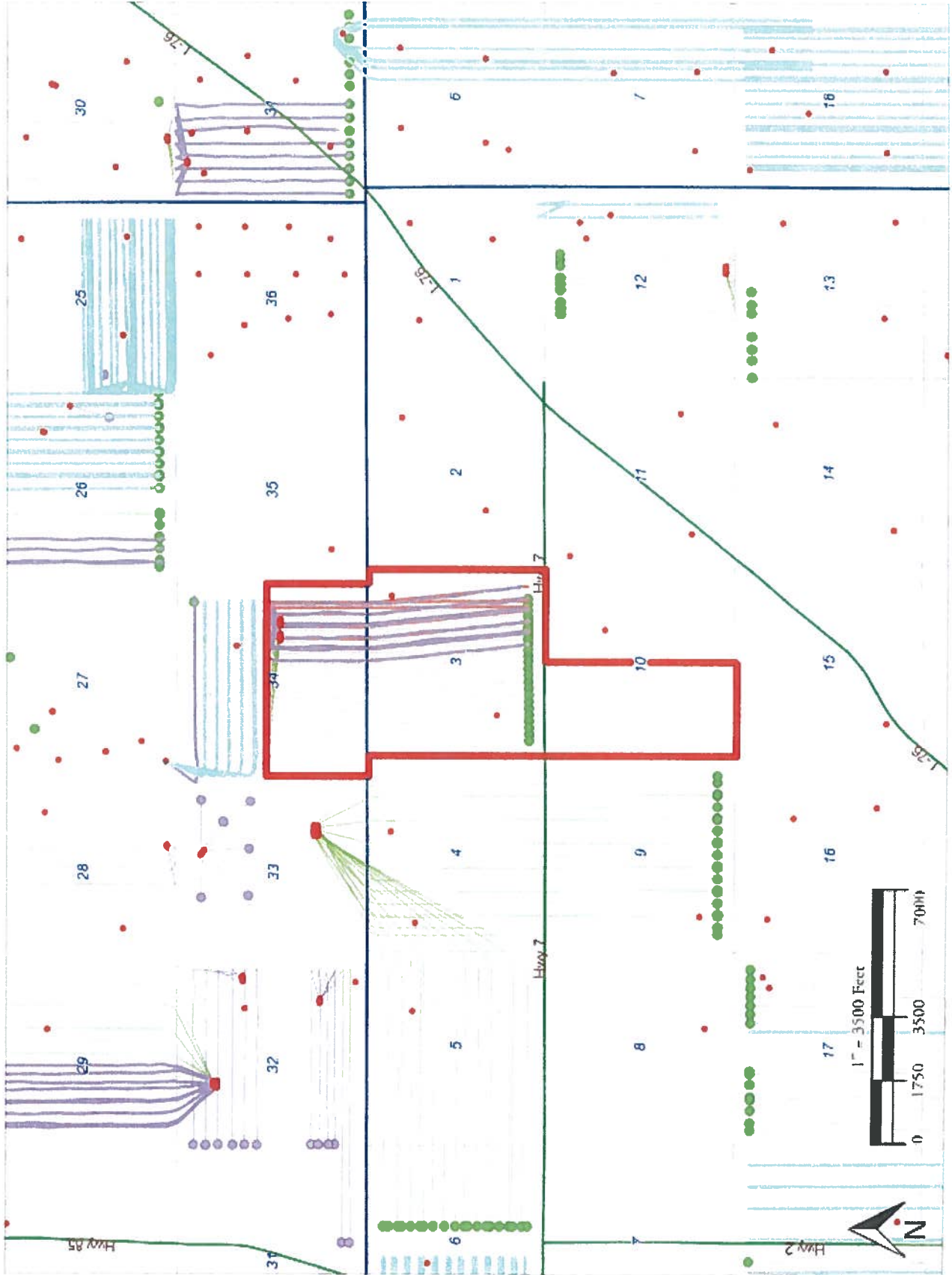
