APPLICATION

On May 5, 2015 (Amended June 4, 2015), Extraction Oil & Gas LLC (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate four approximate 80-acre drilling and spacing units established by Order No. 407-87 for the Application Lands;
- 2) Establish an approximate 320-acre drilling and spacing unit for the Application Lands for the production of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations;
- 3) Approve up to eight horizontal wells within the unit;
- 4) Require that the productive interval of the wellbore to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit;
- 5) Pool all interests in the approximate 320-acre drilling and spacing unit established for the Application Lands for the development and operation of the Codell and Niobrara Formations; and
- 6) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the GP-J Evans 1-19-19 Well (API No. 05-123-41134); GP-J Evans 2-19-19 Well (API No. 05-123-40310); GP-J Evans 3-19-19 Well (API No. 05-123-41137); GP-J Evans 4-19-19 Well (API No. 05-123-41133); GP-J Evans 5-19-19 Well (API No. 05-123-41135), GP-J Evans C4-19-19 (No

API number); GP-J Evans C2-19-19 (No API number); and the GP-J Evans C3-19-19 (No API number).

7) Applicant agrees that the proposed wells shall be drilled from a total of no more than eight locations within the proposed drilling and spacing unit.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week commencing on October 12, 2015. Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
